On October 19, 2022, the Respondent paid the license fees for the period of 2022 to 2023.



However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion.
