12	MR. McGOVERN: And good morning, I'm
13	Matthew McGovern from the Dew Drop Inn, M-C-G-O-
14	V-E-R-N.
15	CHAIRPERSON ANDERSON: Good morning,
16	Mr. McGovern, please, sign-in
17	MR. McGOVERN: Yes.
18	CHAIRPERSON ANDERSON: on the sign-
19	in sheet.
20	Yes, Mr. Adams, are there any
21	preliminary matters in this case?
22	MR. ADAMS: There is a preliminary

matter in this case. The parties have discussed the charges that are here and are willing -- are in a position to make an Offer in Compromise.

There are two charges in this case.

For the -- in this case, we propose a fine in the total amount of \$4,200 to be paid today. And if the licensee fails to pay the fine today, it is aware that the license will be suspended indefinitely until such time the fine is paid.

The -- how it breaks down, Mr.

Chairman, is that for Charge 1, there will be a fine in the amount of \$2,100. And for Charge 2, it will be an additional fine in the amount of \$2,100.

CHAIRPERSON ANDERSON: All right.
Thank you, Mr. Adams.

Mr. McGovern, it's my understanding that there is an Offer in Compromise and the Offer in Compromise is that for Charge 1 there is a fine of \$2,100 payable in 30 days. For Charge 2, there is also a fine of \$2,100 payable -- I'm sorry, payable -- both fines will be payable

1 today. 2 Is this your understanding, sir, of the Offer in Compromise? 3 4 MR. McGOVERN: Yes, sir. 5 CHAIRPERSON ANDERSON: Are you aware that by accepting an Offer in Compromise, that 6 you are giving up your right to a hearing? 7 8 MR. McGOVERN: I'm -- I do now. Yes, 9 sir. CHAIRPERSON ANDERSON: All right. 10 And 11 are you also aware that by giving up your right 12 to a hearing, you are giving up your right to 13 appeal this matter? 14 MR. McGOVERN: I do. 15 CHAIRPERSON ANDERSON: All right. 16 With that said, I then make a motion 17 that the Offer in Compromise of a fine of \$2,100 18 for Charge 1, also a fine of \$2,100 for Charge 2 19 for a total fine of \$4,200 payable today. If the 20 fine is not payable today, the license will be 21 suspended until the fine has been paid.
