**ORDER CANCELLING LICENSE**

The Alcoholic Beverage and Cannabis Administration (ABCA) has reviewed its records and determined that District Still, LLC, t/a District Still (Respondent), license is currently in safekeeping. The Respondent was originally scheduled to pay the Safekeeping fees no later than March 31, 2024. However, the Respondent failed to pay its Safekeeping fees.

Additionally, on April 11, 2014, the Respondent was further notified that if it wished to keep its license in Safekeeping, a written safekeeping extension request must be submitted to the Alcoholic Beverage Control Board (Board), or the license will be cancelled, pursuant to the District of Columbia Official Code § 25-791(c). No such request was received by the Respondent.

It is hereby **ORDERED** on this 1st day of May 2024, that District Still, LLC's License No. ABRA-102521 is **CANCELLED**. A copy of this Order shall be sent to the Respondent.

Pursuant to D.C. Official Code § 25-433(d)(1) (applicable to alcohol matters) or 22-C DCMR § 9720 (applicable to medical cannabis matters), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage and Cannabis Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001 (202/879- 1010). However, the timely filing of a Motion for Reconsideration stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
