The Alcoholic Beverage Control Board met in the Alcoholic Beverage Control Hearing Room, Reeves Building, 2000 14th Street, N.W., Suite 400S, Washington, D.C. 20009, Chairperson Donovan W. Anderson, presiding.

| 9 | MR. ORTIZ: Stephen Ortiz on behalf of |
| 10 | the District of Columbia. |
| 11 | CHAIRPERSON ANDERSON: Good morning, |
| 12 | Mr. Ortiz. |
| 13 | MR. MEDHURST: Chris Medhurst for the |
| 14 | District Taco. |
| 15 | CHAIRPERSON ANDERSON: Say your last |
| 16 | name, sir. |
| 17 | MR. MEDHURST: Medhurst. |
| 18 | CHAIRPERSON ANDERSON: And who are you |
| 19 | with this establishment, sir? |
| 20 | MR. MEDHURST: Sorry? |
| 21 | CHAIRPERSON ANDERSON: What's your |
| 22 | relationship to this establishment? |
| 23 | MR. MEDHURST: I'm the vice president. |
| 24 | CHAIRPERSON ANDERSON: Okay. All |
| 25 | right. Are there any preliminary matters in this |

case?

MR. ORTIZ: Yes, the establishment and the District have entered into an offer in compromise. As to Charge 1, the offer in compromise is that the establishment shall pay 2,000 dollars within 30 days or its license shall be suspended indefinitely until this fine is paid.

CHAIRPERSON ANDERSON: Mr. Medhurst, it's my understanding there's an offer in compromise and the offer in compromise is that there is a fine of 2,000 dollars payable in 30 days. If the fine is not paid within 30 days, your license will be suspended until the fine has been paid. Is this your understanding of the offer in compromise?

MR. MEDHURST: Yes.

CHAIRPERSON ANDERSON: Are you aware that by accepting the offer in compromise that you give up your right to a hearing?

MR. MEDHURST: Yes.

CHAIRPERSON ANDERSON: Are you also aware that by accepting the offer in compromise that you give up your right to appeal this matter?

MR. MEDHURST: Yes.

CHAIRPERSON ANDERSON: With that said,
I make a motion that the offer in comprise of a
fine of 2,000 dollars payable in 30 days be
accepted. If the fine is not paid within 30
days, the license will be suspended until the
fine has been paid. Is there a second?

MEMBER CATO: Second.

CHAIRPERSON ANDERSON: Mr. Cato has seconded the motion. All those in favor, say aye.

(Chorus of aye.)

CHAIRPERSON ANDERSON: Those opposed.

(No audible response.)

CHAIRPERSON ANDERSON: The matter

passes 4-0-0. Mr. Medhurst, you're the manager
- thank you very much. From reading this that

you're the managing member of this establishment.

And I'm going to investigate the history on your

case -- in this case. And this is the one, two,

three, four, five, six -- between -- this case is

from May 2019.

So between December 2015 and May 2019, this is the one, two, three, four, five, six -- the sixth time we have fined your establishment

for not having an ABC manager, sir. And it's not that difficult to have an ABC manager, sir.

MR. MEDHURST: I agree.

CHAIRPERSON ANDERSON: And if you looking at the fine range, the fine range for not having an ABC manager, the fine range is 4,000 to 6,000 dollars, sir. And you're paying 2,000 dollars. It doesn't appear to me that there's any incentive for you, your company to either have an owner or manager available or having other employees for ABC managers, sir.

So I want you to be aware that the Board is not looking favorable if another infraction occurs that we're going to accept a 2,000-dollar fine. The fine range for these continuing violations is four to six thousand dollars, sir.

I need you to be aware of that because if this continues to happen, the Board -- at least as Chair of the Board, and I don't know about the other Board members, I'm not going to accept it. I'm going to accept a fine range that's between four to six thousand.

Because we don't want to fine you. We want to make sure that you comply with the law.

And clearly, you continue paying 2,000 dollars is not an incentive for you to comply with the law, Okay. Have a good day. She'll have you sir. sign off on the accepted number. (Whereupon, the above-entitled matter went off the record at 9:48 a.m.)
