Specifically, the Respondent failed to renew its license by September 30, 2020, the deadline for all Wholesaler's Class B licenses, despite being notified of the renewal date.

On October 28, 2020, the Alcoholic Beverage Control Board (Board) issued an Order to Cease and Desist against the Respondent, pursuant to D.C. Official Code § 25-829 (2001), for failure to renew its Wholesaler's Class B License. The Respondent did not respond to the Order to Cease and Desist.

However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion.
