ORDER DENYING MOTION FOR RECONSIDERATION

The Application filed by Ezra S, Inc., t/a Dix Market (Applicant), for renewal of its Retailer's Class A License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on July 12, 2021. On July 12, 2021, the Board dismissed the Application because the Applicant failed to appear at the Roll Call Hearing. Additionally, the Board dismissed the Protest of Northeast Boundary Civic Association (Association) because the Association's protest letter did not state that the Association was incorporated under the laws of the District of Columbia located within the affected area and did not provide evidence that the Applicant was given at least seven (7) days advanced notice of the Association meeting, in accordance with D.C. Official Code § 25-601(3).

Subsequently, the Applicant has filed a motion for reinstatement that is opposed by the Association and Advisory Neighborhood Commission (ANC). The Applicant avers that he did not receive notice of the required hearing. Nevertheless, the records of the agency show that notice of the hearing was properly provided by email at the email address on file with the agency, the posted placard, and by notice in the D.C. Register

ORDER

Therefore, the Board, on this 4th day of August 2021, hereby **DENIES** the motion for reconsideration. The remaining motions filed by the other parties are moot and do not require consideration at this time. Copies of this Order shall be sent to the Parties.
