ORDER DENYING MOTION FOR RECONSIDERATION

In Board Order No. 2018-189, issued on April 25, 2018, the Alcoholic Beverage Control Board cancelled the license held by TBM Holdings, LLC, t/a Driftwood Kitchen, (Driftwood) and assigned ABRA License No. 086210. The license was cancelled because Driftwood failed to pay its third year license fees by March 31, 2018, as required by law. Driftwood filed a motion for reconsideration, but it is untimely by a number of months. D.C. Code § 25-433(d)(1). As a result, Driftwood's current motion is not eligible for reconsideration, and the cancellation is affirmed.

ORDER

Therefore, the Board, on this 1st day of August 2018, hereby **DENIES** the motion for reconsideration. The ABRA shall deliver a copy of this order to Driftwood.

Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001. However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR § 1719.1 stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
