3 CHAIRMAN ANDERSON: We now move on to
4 our show cause hearing status. The first case on
5 our show cause hearing status is case no. 19-CC-
6 00119, Dupont Market, license number 21578.
7 Would the parties please approach and identify
8 themselves for the record, please.

9 MR. FACCI: Good morning, Mr.
10 Chairman, members of the board. Jason Facci on
11 behalf of the District of Columbia.

12 CHAIRMAN ANDERSON: Good morning, Mr.
13 Facci.

14 MR. SHERIDAN: Good morning. Kevin
15 Sheridan for 1807 Corporation.

16 CHAIRMAN ANDERSON: Good morning, Mr.
17 Sheridan. Mr. Facci, are there any preliminary
18 matters in this case?

19 MR. FACCI: The only preliminary
20 matter, sir, is that the owner of the
21 establishment has requested a continuance of the
22 show cause hearing that is set for February.

23 CHAIRMAN ANDERSON: February 12, 2020.
24 What's your position on that?

25 MR. FACCI: The District does not

1 object to a continuance. The owner has stated
2 that that date does not work for him and some of
3 his potential witnesses. So we are fine with
4 continuing.

5 CHAIRMAN ANDERSON: All right. So
6 we'll work with our legal office and provide you
7 another date for the matter.

8 So this matter will be scheduled for
9 a show cause hearing on a date to be established.
10 We'll make sure that our legal office provides
11 you with the date for the show cause hearing.

12 MR. SHERIDAN: Mr. Chairman, if I
13 could. February is a really difficult month for
14 the three of us that are to be here. And I had
15 requested anytime from March 4 on.

16 Our schedules between kids and travel,
17 there's never a time in those last three weeks of
18 February that we can all be together.

19 From March 4 on the entire month is
20 wide open. I wanted to mention that if you try
21 to schedule from the fourth.

22 CHAIRMAN ANDERSON: That's April 1 at
23 what time? Does April 1 at 11 work?

24 MR. SHERIDAN: Off the top of my head
25 it does. Yes. I'll do my best to make that

1 work.

2 CHAIRMAN ANDERSON: Then this matter
3 is scheduled for April 1, 2020 at 11 a.m.

4 MR. SHERIDAN: Thank you.

5 CHAIRMAN ANDERSON: Because this is a
6 show cause hearing what I expect both sides do
7 seven days before the hearing, I expect both
8 sides to introduce their documents and witnesses
9 that they're going to utilize.

10 So you exchange it with opposing
11 counsel and provide us with a copy of your
12 documents.

13 I don't want any surprises. Whatever
14 documents or witnesses you're going to rely on,
15 that should be disclosed seven days prior. Okay?
16 All right, thank you.

17 MR. SHERIDAN: Thank you.
