4	next case on our calendar is Case No. 18-CMP-
5	00038, Eat First, License No. 60387.
6	Will the parties, please, approach and
7	identify themselves for the record, please?
8	MR. RIVERO: Good morning, Board
9	Members. Fernando Rivero for the District of
10	Columbia.
11	CHAIRPERSON ANDERSON: Good morning.
12	Do we have a translator here?
13	MR. RIVERO: Good morning, yes.
14	CHAIRPERSON ANDERSON: Can you stand
15	up, please, ma'am?
16	INTERPRETER: You mean me?
17	CHAIRPERSON ANDERSON: Yes, you're the
18	translator?
19	INTERPRETER: I'm interpreter.
20	CHAIRPERSON ANDERSON: I'm sorry, the
21	interpreter. What language is this, please?
22	INTERPRETER: Mandarin.

1	CHAIRPERSON ANDERSON: Mandarin.
2	Mandarin Chinese?
3	INTERPRETER: Yes.
4	CHAIRPERSON ANDERSON: Okay. Raise
5	your right hand, please.
6	Do you swear or affirm to faithfully
7	translate/interpret these proceedings from
8	English to Mandarin Chinese and from Mandarin
9	Chinese to English?
10	INTERPRETER: Yes, I do.
11	CHAIRPERSON ANDERSON: Okay. Have a
12	seat, please.
13	INTERPRETER: Thank you.
14	CHAIRPERSON ANDERSON: Can you,
15	please, then identify yourself for the record,
16	sir?
17	MR. LI: Yes, I'm the owner of the Eat
18	First restaurant.
19	CHAIRPERSON ANDERSON: What is your
20	name, sir?
21	MR. LI: It's Yi Li, the owner of the
22	Eat First restaurant.

1	CHAIRPERSON ANDERSON: All I need is
2	just for you to tell me what your name is.
3	MR. LI: The first name just Y-I, Yi.
4	The last name L-I, Li.
5	CHAIRPERSON ANDERSON: Thank you.
6	Good morning, sir.
7	MR. LI: Li, just call me Li.
8	CHAIRPERSON ANDERSON: Good morning,
9	sir. All right. Mr. Rivero, are there any
LO	preliminary matters in this case?
L1	MR. RIVERO: Yes, there are. The
L2	parties have an Offer in Compromise to present to
L3	the Board, at this time.
L4	The offer for Charge 1 is a fine of
L5	\$1,500 and the offer for Charge 2 is a fine of
L6	\$1,500 for a total fine of \$3,000 and it will be
L7	payable in 90 days. If the fine is not paid in
L8	90 days, the license will be suspended until the
L9	payment is received. That is the offer.
20	CHAIRPERSON ANDERSON: Good morning
21	again, Mr. Li.
22	MR. LI: Yes.

1	CHAIRPERSON ANDERSON: It's my
2	understanding that there is an Offer in
3	Compromise and the offer is for Charge 1 there is
4	a fine of \$1,500. For Charge 2, there is a fine
5	of \$1,500. The total fine of \$3,000 will be
6	payable in 90 days. If the fine is not payable
7	in 90 days, the license will be suspended until
8	the fine has been paid.
9	Is this your understanding, sir, of
10	the Offer in Compromise?
11	MR. LI: Yeah, I understand that, yes.
12	CHAIRPERSON ANDERSON: Are you aware
13	that by accepting an Offer in Compromise, that
14	you are giving up your right to a hearing?
15	INTERPRETER: Excuse me, would you
16	repeat?
17	CHAIRPERSON ANDERSON: Are you aware
18	that by giving by accepting an Offer in
19	Compromise, that you are giving up your right to
20	have a hearing on this matter?
21	MR. LI: Yeah. Yes.
22	CHAIRPERSON ANDERSON: Are you also

aware that by accepting an Offer in Compromise, 1 2 that you are giving up your right to appeal this 3 matter? 4 MR. LI: Yes, yes. 5 CHAIRPERSON ANDERSON: All right. With that said, I then make a motion that the 6 Offer in Compromise of a fine of \$1,500 on Charge 7 1 and \$1,500 on Charge 2 be accepted. 8 If the 9 fine is not payable in 90 days, the license will 10 be suspended until the fine has been paid. 11 there a second? 12 MEMBER SHORT: Second. 13 CHAIRPERSON ANDERSON: Mr. Short has 14 seconded the motion. All those in favor say aye. 15 ALL: Aye. 16 CHAIRPERSON ANDERSON: All those 17 opposed? The matter passes 6-0-0. Thank you. 18 are going to have you sign some paperwork and you 19 have to make sure that 90 days from today, the 20 fine is paid.
