ORDER RESCINDING APPROVAL OF ABRA LICENSE NO. ABRA-117794

RT, LLC, t/a Ella Grace (Applicant), filed an Application for a Retailer's Class CT License (Application) at 1421 H Street, NE, Washington, D.C. The Application was approved under Title 23 of the District of Columbia Municipal Regulations (DCMR) § 405.1, which authorizes the Alcoholic Beverage Control Board (Board) to issue a license to an applicant that lacks a certificate of occupancy for the premises so long as the applicant satisfies the requirements of Title 23 of DCMR 405.1.

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that the Applicant has failed to renew its license and pay the license fees for its License No. ABRA-117794. Specifically, despite written notice, the Applicant failed to renew its license and pay the license fees by September 30, 2022, the deadline for all Retailer's CT licenses.

Therefore, on this 15th day of February 2023, the Board **RESCINDS** approval of RT, LLC's Application, License No. ABRA-117794. A copy of this Order shall be sent to the Applicant.
