10 The protest issues are adverse impact
11 on peace, order and quiet, residential parking

25 Behzad or David Fox? The application is

1 dismissed because the applicant failed to appear.
2 The protest filed by Tony Behzad -- I'll spell
3 that for the record -- T-O-N-Y, last name is
4 spelled B-E-H-Z-A-D -- is dismissed because he is
5 not present today.

6 Ms. Norman, the Board is going to
7 issue an order dismissing those protests. You'll
8 receive a copy, of course, and there's no need to
9 set a date for any hearings --

10 MS. NORMAN: Okay.

11 MS. FLETCHER: -- because all the
12 parties are not present. But you'll be kept
13 informed. They'll have an opportunity to seek
14 reinstatement of the protest, but you'll be kept
15 informed along the way.

16 But as of today, the application is
17 dismissed as well as the protest filed by Tony
18 Behzad. The time is approximately 10:27 and
19 neither one of them are present.

20 Thank you. The roll call hearing is
21 concluded.
