3 AGENT FLETCHER: Would the parties in  
4 the matter of FB Liquors please come forward, the  
5 parties in the matter of FB Liquors? This is  
6 Case number 18-PRO-00049.

7 FB Liquors, LLC, 1905 9th Street NW,  
8 License number ABRA-105842. This is a Retailer  
9 Class A license renewal. The protest issues are  
10 adverse impact on peace, order, and quiet.

11 My name is LaVerne Fletcher,  
12 conducting the Roll Call Hearing as the Board's  
13 agent. Introductions, beginning with the  
14 applicant, please.

15 MR. FAJI: Fayisa Faji, owner.

16 AGENT FLETCHER: And could you spell  
17 the first name?

18 MR. FAJI: F-A-Y-I-S-A.

19 AGENT FLETCHER: And the last name?

20 MR. FAJI: F-A-J-I.

21 AGENT FLETCHER: And could you put  
22 that on the --

1 MR. FAJI: I did.

2 AGENT FLETCHER: Oh, you did already.

3 MR. FAJI: Yes.

4 AGENT FLETCHER: Thank you.

5 MR. GEMECHU: Bayissa Gemechu.

6 AGENT FLETCHER: And can you spell the  
7 first name?

8 MR. GEMECHU: B-A-Y-I-S-S-A.

9 AGENT FLETCHER: V-A, did you say V  
10 like Victor?

11 MR. GEMECHU: No. B as in boy.

12 AGENT FLETCHER: Okay. A-Y --

13 MR. GEMECHU: I-S-S-A.

14 AGENT FLETCHER: And what's the last  
15 name?

16 MR. GEMECHU: Gemechu, G-E-M-E-C-H-U.

17 AGENT FLETCHER: Thank you. And who's  
18 the owner?

19 MR. GEMECHU: Both.

20 AGENT FLETCHER: You both?

21 MR. GEMECHU: Yes.

22 AGENT FLETCHER: So, who's going to be

1 the contact person?

2 MR. FAJI: I am.

3 AGENT FLETCHER: Okay. So, Mr. Sanji

4 --

5 MR. FAJI: Faji.

6 AGENT FLETCHER: Faji. Your contact  
7 information is already on the sheet, right?

8 MR. FAJI: Yes.

9 AGENT FLETCHER: Okay. Thank you.

10 MR. FAJI: Okay.

11 AGENT FLETCHER: Is anyone present on  
12 behalf of ANC 1B? ANC 1B is dismissed because  
13 they are not present today. What will happen is  
14 the ABC Board is going to issue an order  
15 dismissing the protest filed by ANC 1B. And  
16 you'll be kept informed. You'll receive a copy  
17 of the order.

18 ANC 1B will have ten days to seek  
19 reinstatement of the protest for good cause, for  
20 not being present today. The ABC Board will  
21 review their request for reinstatement, if they  
22 seek reinstatement. They may not. But you'll be

1 kept informed.

2 MR. FAJI: Okay.

3 AGENT FLETCHER: And so, any questions  
4 about that?

5 MR. FAJI: No. But we didn't receive  
6 any, the petition, any submitted to ABRA.

7 AGENT FLETCHER: Oh, you --

8 MR. FAJI: Just the notification from  
9 ABRA about --

10 AGENT FLETCHER: You didn't receive a  
11 Roll Call Hearing notice from us to appear today?

12 MR. FAJI: Just from ABRA.

13 AGENT FLETCHER: Yes. But did you  
14 receive a, you didn't receive a copy of their  
15 protest?

16 MR. FAJI: Yes, no.

17 AGENT FLETCHER: Oh, so you didn't get  
18 a copy of their protest letter?

19 MR. FAJI: Yes. We recall us making  
20 no nothing.

21 AGENT FLETCHER: Okay. Excuse me one  
22 second.

1 MR. FAJI: We just receive a hearing  
2 call form.

3 AGENT FLETCHER: Right. You just  
4 received the notice from us to appear.

5 MR. FAJI: Yes.

6 AGENT FLETCHER: But you didn't get a  
7 copy of their protest letter.

8 MR. FAJI: Yes.

9 AGENT FLETCHER: Excuse -- thank you.  
10 One second. If you have a moment to wait, at the  
11 end of this hearing I will make a copy for you.

12 MR. FAJI: Okay.

13 AGENT FLETCHER: You should have  
14 received a copy of this protest letter, should  
15 have been included with your notice. The notice  
16 that you received.

17 MR. FAJI: Is that this one?

18 AGENT FLETCHER: That's it.

19 MR. FAJI: Oh, this one.

20 AGENT FLETCHER: Yes.

21 MR. FAJI: Okay.

22 AGENT FLETCHER: Yes, that's it.

1 MR. FAJI: Yes.

2 AGENT FLETCHER: Yes.

3 MR. FAJI: So, we didn't handle the  
4 triage (phonetic) for our building. So, there is  
5 two tenants. We are co-tenants in this.

6 AGENT FLETCHER: Oh, yes. And yes,  
7 for the roll, we can talk about it later. So,  
8 right now there's not a protest pending.

9 MR. FAJI: Okay. Okay.

10 AGENT FLETCHER: If they, if the Board  
11 grants standing to the ANC as a protestant we'll  
12 talk about it then.

13 MR. FAJI: Okay.

14 AGENT FLETCHER: Okay. Well then,  
15 thank you very much for coming.

16 MR. FAJI: Thank you very much.

17 AGENT FLETCHER: The Roll Call Hearing  
18 is concluded. Thank you.
