2	CHAIRPERSON ANDERSON: The next case
3	on our calendar is Case Number 21-PRO-00082,
4	Fairfax Liquor, License Number 78013.
5	Now, Ms. Fashbaugh, could you please
6	elevate the rights of the parties in this case,
7	please.
8	MS. FASHBAUGH: One moment. Kyunghwan
9	Lee, your rights have been elevated. And Tiffany
10	Brown, I'm unable to elevate you, but I'm
11	unmuting you.
12	MS. BROWN: Okay.
13	MS. FASHBAUGH: That is all, Mr.
14	Chair.
15	CHAIRPERSON ANDERSON: Thank you. All
16	right. I just I just wanted to is Ms.
17	Brown Ms. Brown, are you could the parties
18	please identify themselves on the record. Let's
19	start with the licensee.
20	Mr. Lee, you're on mute. I cannot
21	hear you, sir.
22	(Pause.)
23	CHAIRPERSON ANDERSON: I still cannot
24	hear you. Mr no, I cannot hear you, Mr. Lee.
25	Say something, Mr. Lee.

2	CHAIRPERSON ANDERSON: I still cannot
3	hear you.
4	Ms. Fashbaugh, did you unmute him, or
5	is it that he's having technical issues?
6	MS. FASHBAUGH: He's unmuted.
7	CHAIRPERSON ANDERSON: Okay. No, Mr.
8	Lee. Why don't you sign off, Mr. Lee, and come
9	back on, please.
10	Ms. Brown, I believe you can can
11	you put your microphone on mute, please.
12	
13	(Pause.)
14	MS. FASHBAUGH: Kyunghwan Lee, I
15	elevated your rights, and Tiffany Brown, I'm
16	unmuting you.
17	MR. LEE: Hello?
18	CHAIRPERSON ANDERSON: Yes, Mr. Lee?
19	MR. LEE: You can hear me now?
20	CHAIRPERSON ANDERSON: Yes, sir.
21	MR. LEE: Awesome.
22	CHAIRPERSON ANDERSON: I can hear you.
23	Can you please spell and state your name for the
24	record, please.
25	MR. LEE: Yes. My name is Kyunghwan

1 Lee, K-Y-U-N-G-H-W-A-N, last name, L-E-E. I 2 represent for Fairfax Liquors. 3 CHAIRPERSON ANDERSON: Good morning, 4 Mr. Lee. Is your client going to be online 5 today? MR. LEE: No, he's not here. 6 He had 7 a surgery. Yeah. 8 CHAIRPERSON ANDERSON: All right. 9 Thank you. 10 Ms. Brown, can you please spell and 11 state your name for the record, please. 12 MS. BROWN: Sure. Tiffany L. Brown. 13 T-I-F-F-A-N-Y, middle initial L, last name, 14 Brown, B-R-O-W-N. 15 CHAIRPERSON ANDERSON: Thank you, Ms. 16 I -- all right. I just want to state for 17 the record that this is -- this matter has been 18 protested by ANC7B. 19 Prior to joining the Board, or soon 20 after the joining the Board, I was an ANC 21 representative, and I actually represented 22 ANC7B06, where Fairfax Liquor is a licensed 23 establishment in the ANC that I represented. 24 But however -- and I -- Ms. Brown is the chair of the ANC, and I know Ms. Brown. 25

However, although this establishment was in the single-member district that I represented and that over four years ago, I do not believe I did not have -- as the ANC representative, I did not file a protest.

And four years later, I do not believe

And four years later, I do not believe that because this establishment was in the ANC that I represented -- the single-member district that I represent, that this will in any way influence my decision.

I believe that I'm able to make a decision without any bias and being impartial to the parties. I just want to place that on the record. Thank you. I appreciate it.

MEMBER SHORT: Mr. Chair?

CHAIRPERSON ANDERSON: Yes, Mr. Short?

MEMBER SHORT: I'd also like to
acknowledge that I live in that ANC District 7B
and that it will have no bearing on my decision-

making involved in this case.

CHAIRPERSON ANDERSON: All right.

22 Thank you, Mr. Short, for that representation.

All right. Are there any preliminary matters in this case?

MR. LEE: Yeah, I believe that we

almost are finalizing the -- finalized the status of settlement agreement. So that's what I believe, and we just talked yesterday, and I'll just wait for finalize -- the settlement to be signed.

CHAIRPERSON ANDERSON: Thank you.

MS. BROWN: Sir, that is correct.

That's correct.

CHAIRPERSON ANDERSON: All right.

Thank you, Ms. Brown. I don't -- based on the -- based on what I'm hearing from the parties, it's not apparent that we're going to have the hearing.

However, as I stated before with this matter, if we go to a hearing, we'll have a hearing on February 16, 2022. If either party have any questions, please feel free to reach out to Ms. Imani Moreland. Her phone number is 202-442-6942.

And as I have stated previously, the
Board supports settlement agreement if the
parties are able to agree to a settlement
agreement because this is their -- this is the
neighborhood that the Applicant and the ANC
resides in. And so we would support that.
