3 CHAIR ANDERSON: The next case on our
4 calendar is Case Number 19-CIT-00408, Fantom
5 Comics, License Number 107167. Would the parties
6 please approach and identify themselves for the
7 record, please?

8 MR. BISHOP: Hi, my name is David
9 Bishop, I'm the owner of Fantom Comics.

10 CHAIR ANDERSON: Good morning, Mr.
11 Bishop.

12 MR. BISHOP: Good morning.

13 MR. LUI: Good morning, John Lui on
14 behalf of the District of Columbia.

15 CHAIR ANDERSON: Good morning again,
16 Mr. Lui. Are there any preliminary matters in
17 this case?

18 MR. LUI: Yes, there is an offer in
19 compromise to present.

20 CHAIR ANDERSON: And what is that,
21 please?

22 MR. LUI: For Charge 1, no ABC manager,
23 this is a second tier violation, the offer in
24 compromise is a warning.

25 CHAIR ANDERSON: All right. Mr.

1 Bishop, it's my understanding there is an offer
2 in compromise. And the offer in compromise is
3 that a written warning will be issued. Is this
4 your understanding of the offer in compromise?

5 MR. BISHOP: Yes, that's my
6 understanding.

7 CHAIR ANDERSON: Are you aware that by
8 accepting an offer in compromise, that you're
9 giving up your right to a hearing?

10 MR. BISHOP: Yes, I understand.

11 CHAIR ANDERSON: Are you also aware
12 that by accepting an offer in compromise, that
13 you're giving up your right to appeal this
14 matter?

15 MR. BISHOP: Yes, I understand that as
16 well.

17 CHAIR ANDERSON: All right. With that
18 said, I make a motion that the offer in
19 compromise of a written warning be accepted. Is
20 there a second?

21 MEMBER SHORT: Second.

22 CHAIR ANDERSON: Mr. Short has seconded
23 the motion. All those in favor, say aye.

24 (Chorus of ayes.)

25 CHAIR ANDERSON: Those opposed? The

1 matter passes, 5-0-0. Thank you. I will have
2 you sign off on -- well, this one will be your
3 copy.

4 MR. BISHOP: All right, thanks.

5 CHAIR ANDERSON: So, I will have you
6 sign off on this paperwork, sir. And thank you.

7 MR. BISHOP: Thank you.
