Ms. Fashbaugh, can you please elevate the rights of the parties in this case, including the government. I think it's Mr. Stephen Ortiz who is the government representative.

CHAIRPERSON ANDERSON: Good morning. I see that the license is not here. This matter, then, is scheduled for a show-cause hearing on January 26, 2022, at 1:30 p.m.

MR. ORTIZ: Good morning, Mr. Chairperson. I do have just one question regarding this case that you just called.

CHAIRPERSON ANDERSON: Yes, Mr. Ortiz.

MR. ORTIZ: And my apologies, I'm just having a little bit of connection issues. I just want to make sure that you, for my own record, that you called both of the Felicity Lounge cases?

CHAIRPERSON ANDERSON: I only called one Felicity Lounge case, and maybe I was not following my own instructions this morning, but the calendar that I have, only one case is listed. This morning when it was presented, I thought I heard two cases, so let me see if I can find the calendar, so I will have the number for the second case.

Thank you for bringing that to my attention, but I only have I need to find the other case, so once I find the other case I can call that number.

MR. ORTIZ: Understood. I'm also
looking for the most recent calendar that I have.
CHAIRPERSON ANDERSON: All right.

The second Felicity Lounge case is case number 21CMP00041, Felicity Lounge licensee number 112502. Mr. Ortiz, can you please identify yourself for the record.

MR. ORTIZ: Yes, sir. Good morning, Mr. Chairperson, Stephen Ortiz on behalf of the

District of Columbia. That's S-T-E-P-H-E-N O-R-T-I-Z.

CHAIRPERSON ANDERSON: All right. And the licensee is not here. We had called the case, and he was not here. Again, it is my understanding that the licensee was properly served on October 29, 2021. So this matter, then, is scheduled for a show-cause hearing on January 26, 2022, at 1:30 p.m.
