7 Street, NW, license number ABRA-008004. This is  
8 a Retailer Class CR License renewal.

9 The protest issues are adverse impact  
10 on peace, order and quiet.

12 conducting the Roll Call Hearing as the board's

17 which is, unfortunately, why we have spent our  
18 morning here today, but I don't know that -- it  
19 is up to you if we need to set these dates, or  
20 not.

21 MS. FLETCHER: Not at all.

22 (Pause.)

1 MS. FLETCHER: So, Ms. Palmer, you are  
2 going to -- you have to vote on it first?

3 MS. PALMER: No, I can sign it. It is  
4 the Citizens Association of Georgetown that will  
5 sign it tonight.

6 MS. FLETCHER: Okay. So then, I've  
7 noted and it is on the record also, that a  
8 settlement agreement is forthcoming.

9 MS. PALMER: The Applicant's already  
10 signed it.

11 MS. FLETCHER: No need to set any  
12 dates. Thank you for coming.

13 MS. PALMER: Thank you.

14 MS. FLETCHER: This roll call hearing  
15 is concluded. Thank you.
