4	next case is that we have a Fact-Finding Hearing,
5	Fortune Liquors, License No. 105355.
6	Would the parties, please, approach
7	and identify themselves for the record, please?
8	Good morning, sir. You are can you
9	identify yourself for the record, please? Your
10	name?
11	MR. ZHANG: Chuan Tu Zhang.
12	CHAIRPERSON ANDERSON: I'm sorry, I
13	didn't hear.
14	MR. ZHANG: Chuan Tu Zhang.
15	CHAIRPERSON ANDERSON: Trong?
16	MR. ZHANG: Tu Zhang.
17	CHAIRPERSON ANDERSON: Oh, Chuan. Mr.
18	Zhang, good morning, sir, yes.
19	MR. ZHANG: Yeah, I just right now,
20	I got a boss that is
21	CHAIRPERSON ANDERSON: Speak a little
22	bit slower, sir, so I can hear you, please.

1	MR. ZHANG: I'm sorry. I only know to
2	be two or three years that the license, so why
3	not
4	CHAIRPERSON ANDERSON: You can have a
5	seat.
6	MEMBER SILVERSTEIN: Sit down and
7	speak into the microphone, please.
8	CHAIRPERSON ANDERSON: Hold on. Yes,
9	you can have a seat and make yourself
10	comfortable, sir.
11	MR. ZHANG: Yeah. I already know the
12	liquor license two or three years, so why not we
13	don't have time for like the basement. I got the
14	boss coming in now. Also right now, I will sale
15	to my friend. He need it, liquor license now.
16	CHAIRPERSON ANDERSON: So have you
17	hold on. Well, sir, you know that when your
18	safekeeping request is only for six months.
19	MR. ZHANG: I'm sorry?
20	CHAIRPERSON ANDERSON: If you if we
21	were to grant the request for safekeeping, it
22	would only be for six months. And I see in your

1 letter you are asking for another two to three 2 years. So what is it that -- so you believe that -- you have an A License, right? You have a 3 4 liquor store license. 5 Right, right. MR. ZHANG: CHAIRPERSON ANDERSON: So you have had 6 this for a while, so why can't you find a 7 8 location? 9 MR. ZHANG: Yeah, I check it on 10 location two, so also we don't have a car. I got 11 a bus. I got a -- next year I buy the bus and 12 bus company. 13 CHAIRPERSON ANDERSON: Slower, sir, 14 slower for me, please. 15 MR. ZHANG: Yeah, I say I -- we don't 16 have time. I go look at all the location and got 17 the bus and bus company. I buy the bus and bus 18 company. We don't have time to look at other 19 location. 20 CHAIRPERSON ANDERSON: No, I'm sorry, 21 you said you buy what? 22 MR. ZHANG: The bus. B-U-S, bus. Bus

1 company. 2 CHAIRPERSON ANDERSON: Bus company? Bus? 3 4 MR. ZHANG: Yeah. 5 CHAIRPERSON ANDERSON: You buy a bus 6 company? I don't --7 MR. ZHANG: Me, I buy the bus company. 8 We just don't have a driver. 9 CHAIRPERSON ANDERSON: Right. Yeah, location of that. 10 MR. ZHANG: Cannot -- we don't have a car to look at the 11 12 location. CHAIRPERSON ANDERSON: You know what? 13 14 This is what I'm going to do, sir. I'm having a 15 difficult time understanding you. 16 MR. ZHANG: Okay. 17 CHAIRPERSON ANDERSON: What language 18 do you speak? 19 MR. ZHANG: Mandarin. 20 CHAIRPERSON ANDERSON: Mandarin Chinese. 21 I think I'm going to ask that we 22 provide you an interpreter, because I'm having a

1	difficult time understanding you.
2	MR. ZHANG: Okay.
3	CHAIRPERSON ANDERSON: And I want to
4	be fair to you. I know that you are asking for
5	two to three years
6	MR. ZHANG: Yeah.
7	CHAIRPERSON ANDERSON: to continue
8	this license. And I'm that's not even
9	allowable. And I'm not quite sure why is it that
10	you have had this license until since you
11	have had this license now for three years.
12	MR. ZHANG: Yes, two to be
13	CHAIRPERSON ANDERSON: Yeah, in
14	October of 2015 you got this license. It's a
15	very valuable license. I mean, there is a cap on
16	A Licenses, so you have the license and you are
17	not using it. And you are telling us that you
18	are going to you probably are not going to use
19	it for another two to three years.
20	MR. ZHANG: Yeah, I know. So which is
21	why I want we don't have time. I haven't look
22	out at location, too, so I've got to work boss

1 that's very, very busy. So right now, I got my 2 friend also you need it for the liquor license might need it for sale for my friend, too. 3 4 CHAIRPERSON ANDERSON: So have you --5 MR. ZHANG: Yeah. CHAIRPERSON ANDERSON: 6 -- come --7 okay. So you said you are going to give it --8 you are going to sell it to someone? 9 MR. ZHANG: Yeah, yeah, yeah. 10 CHAIRPERSON ANDERSON: So have you put 11 in any paperwork here to transfer the license to 12 them? 13 MR. ZHANG: Yeah, I also got the 14 paperwork, too, uh-huh. 15 CHAIRPERSON ANDERSON: What have you? 16 What? Tell me what. 17 MR. ZHANG: Oh, like a -- okay, hold 18 on one second. 19 CHAIRPERSON ANDERSON: Who are you, sir? 20 21 MR. ZHANG: He kind of the --22 Who is the guy CHAIRPERSON ANDERSON:

1 next to you? 2 MR. WANG: Can I show this to you? Mr. Zhang write this one and this is, you know, 3 4 sales approvement. And the other gentleman --MEMBER SILVERSTEIN: You need to speak 5 into the microphone, please. 6 7 CHAIRPERSON ANDERSON: You have to go 8 back there and speak into the microphone. Go 9 ahead. All right. Hold on. Is it on? 10 MR. WANG: 11 CHAIRPERSON ANDERSON: Yeah, you can 12 sit there. 13 MR. WANG: I'm a CPA. My name is Neng 14 Hsiang Wang. I help Mr. Zhang to come up with some kind of solution. And the solution is to 15 16 sell to a friend of Mr. Zhang and this gentleman 17 is called Mr. Shi, S-H-I. He is now sitting over 18 there and he is willing to purchase the license. 19 So if you -- if the owner agree therefore the 20 transfer, he is willing that to buy and operate 21 this license right away. 22 CHAIRPERSON ANDERSON: Okay. Yes, Mr.

1 Short? Go ahead, Mr. Short. 2 MEMBER SHORT: Mr. CPA? 3 MR. WANG: Yes. 4 CHAIRPERSON ANDERSON: I'm sorry, 5 what's your name for the record, sir? Neng Hsiang Wang. 6 MR. WANG: CHAIRPERSON ANDERSON: What is your 7 8 name? 9 Neng Hsiang Wang. MR. WANG: 10 CHAIRPERSON ANDERSON: No, just --11 MEMBER SHORT: No, no, no. 12 CHAIRPERSON ANDERSON: -- spell it. 13 Write it on this sign-in sheet there. And also 14 spell it for the record. Spell your name also, 15 sir. 16 MR. WANG: Okay. Neng Hsiang Wang is 17 N-E-N-G H-S-I-A-N-G last name is W-A-N-G. 18 CHAIRPERSON ANDERSON: All right. And 19 so, Mr. Wang, so there is a sign-in sheet, so 20 make sure you sign-in on the sign-in sheet on the 21 table, too. I think it is maybe that paperwork 22 in front of you. Is there a sign-in sheet there?

All right. I know, but --1 2 MEMBER SHORT: Both of you have to 3 sign-in. Okay. Mr. Wang? 4 CHAIRPERSON ANDERSON: You can leave 5 it right there. Leave it on the table. 6 MEMBER SHORT: Mr. Wang? 7 MR. WANG: Yes. 8 MEMBER SHORT: Now, you are stating that the current owner of this ABC License wants 9 to sell and transfer it to the person who is 10 11 sitting behind you, correct? 12 MR. WANG: I didn't -- no, I'm -- I 13 have some hearing problem. Can you say one more 14 time? 15 MEMBER SHORT: It's my understanding 16 that the current owner, who is sitting beside you, wants to sell his ABC License, which he 17 18 wants to keep in safekeeping, to the person behind you. 19 20 MR. WANG: Um-hum. 21 MEMBER SHORT: Sitting in the audience. 22 Is that correct?

1	MR. WANG: That's correct.
2	MEMBER SHORT: Is that person also
3	going to put it in safekeeping?
4	MR. WANG: Is that what?
5	MEMBER SHORT: Is he going to put it
6	in safekeeping also?
7	MR. WANG: No.
8	MEMBER SHORT: Or does he have a
9	location?
10	MR. WANG: Well, for the time being,
11	but he want to find another location.
12	MEMBER SHORT: Well, what's the
13	difference in him having by keeping

15	location, he has to put in safekeeping for maybe
16	for a short while.

18	preparations have you made to transfer it? Is
19	there a contract? A sale in place already?
20	MR. WANG: There is agreement.
21	CHAIRPERSON ANDERSON: Dated today.
22	MEMBER SHORT: Okay. What's the

22	why doesn't the person behind you who wants to

7	MR. WANG: Because we don't know there
8	is any moratorium or not. There is certain
9	moratorium, then that be restrictions, right?
10	MEMBER SHORT: What's
11	MR. WANG: So we have to buy it from
12	safekeeping.
13	MEMBER SHORT: What's the address of
14	the current license?
15	MR. WANG: Huh?
16	MEMBER SHORT: What is the address of
17	the current license?
18	MR. WANG: I supposed to transfer.
19	MEMBER SHORT: What is the address?
20	MR. WANG: Address?
21	MEMBER SHORT: Yes, of the current

1 the license? 2 MR. WANG: Not open yet. Before we're not open yet. I just check it out and locate --3 4 MEMBER SHORT: How many years? How 5 many years have you had your license? 6 MR. ZHANG: Two or three years. 7 MEMBER SHORT: Two or three years. 8 MR. WANG: Three years. 9 (Simultaneous speaking) 10 MEMBER SHORT: Okay. And so then you want to sell it --11 12 MR. WANG: I think like July --13 MEMBER SHORT: -- to --14 MR. WANG: -- '16. The beginning of July '16. 15 16 MEMBER SHORT: And then you want to 17 sell it to someone else to put it in safekeeping? 18 MR. WANG: That's correct. 19 MR. ZHANG: No. 20 MR. SHI: No. 21 MR. WANG: Sell it for operation. 22 MEMBER SHORT: Okay. You mentioned

moratorium a minute ago. Where is the moratorium 1 2 that you -- that is going to affect this license? 3 MR. WANG: Say again. Where is the moratorium 4 MEMBER SHORT: 5 that you spoke of a moment ago? Oh, we don't know, but --6 MR. WANG: MEMBER SHORT: 7 No. 8 -- we are not familiar MR. WANG: 9 whether that is in moratorium or not, but some people said that there could be a moratorium, you 10 11 know, to a certain degree, but maybe that's 12 correct, maybe that's not correct. 13 MEMBER SHORT: So may be correct, may 14 not be correct. 15 That's correct. MR. WANG: 16 MEMBER SHORT: So what is this Board 17 to act on correct or not correct? 18 MR. WANG: Maybe you can answer that 19 question. 20 MEMBER SHORT: Oh, we will. That's 21 all I have, Mr. Chair. 22 Thank you. MR. WANG: Okay. We need

1 your advice. 2 MR. ZHANG: Thank you. Thank you. MEMBER SHORT: That's all I have, Mr. 3 4 Chair. Thank you very much. 5 CHAIRPERSON ANDERSON: All right. MEMBER SHORT: We will take care of 6 7 it. 8 CHAIRPERSON ANDERSON: Mr. Jin Cai Shi? 9 10 You got my friend, yeah. MR. WANG: 11 CHAIRPERSON ANDERSON: What's your --12 state your name for the record, sir. 13 MR. SHI: J-I-N C-A-I S-H-I, Jin Cai Shi. 14 15 CHAIRPERSON ANDERSON: Mr. Shi? 16 MR. SHI: Yes, sir. 17 CHAIRPERSON ANDERSON: Now, so you 18 want to buy this liquor license --19 MR. SHI: Yes. 20 CHAIRPERSON ANDERSON: -- from him? 21 Do you have a location that you are going to 22 operate this liquor license, sir?

1 MR. SHI: Right now, no. I'm try to 2 look. CHAIRPERSON ANDERSON: 3 Have you -- how 4 hard have you been -- this is the problem that we 5 are having. Okay? He has had this liquor 6 license for three years. 7 MR. ZHANG: Yeah, I got to work the 8 bus. I got a bus company. Bus company. 9 CHAIRPERSON ANDERSON: You own a bus 10 company. 11 MR. ZHANG: Yes. 12 CHAIRPERSON ANDERSON: Okay. Now, we're making sense. I didn't understand what --13 14 because you were talking about bus and we are 15 talking about liquor license. 16 MR. ZHANG: Right, yeah. 17 CHAIRPERSON ANDERSON: So you own a 18 bus company. So you drive a whole lot, so you 19 don't have enough time to --20 MR. ZHANG: Yeah, no, also have no 21 time. It's not easy, you know. 22 CHAIRPERSON ANDERSON: Right. So you

don't have enough time to go find --1 2 MR. ZHANG: Yes. CHAIRPERSON ANDERSON: -- a location. 3 4 MR. ZHANG: Yes, I got to look at a 5 location, too. CHAIRPERSON ANDERSON: All right. 6 7 MR. ZHANG: I got time to get out, 8 so --9 CHAIRPERSON ANDERSON: What's your --10 but you drive a bus company. 11 MR. ZHANG: This is what I want. We 12 don't have time to open. 13 CHAIRPERSON ANDERSON: All right. 14 MR. ZHANG: And make a store. 15 CHAIRPERSON ANDERSON: All right. 16 MR. ZHANG: So this is why I sale for 17 my friend. 18 CHAIRPERSON ANDERSON: So he has had 19 this license for three years. 20 MR. WANG: Two. 21 MR. ZHANG: Two years. 22 No, sir, in CHAIRPERSON ANDERSON:

your letter to us, you said that you acquired the 1 2 license in October of 2015. So October is going That's what your letter says. 3 to be three years. 4 I can check our record, but at least the letter--5 Actually, by July would be MR. WANG: 6 three -- would be two years. So not the two 7 years yet. 8 MR. ZHANG: Talk about to me. By the 9 contract only two years. CHAIRPERSON ANDERSON: All right. 10 Hold on. You wrote a letter to us that 11 Hold on. 12 Mr. Wang, you were copied of it -- you were 13 copied on the letter, and you said that you 14 bought this license in October of 2015. That's 15 what your letter says. 16 I'm not sure what the ABRA record 17 says, but your letter to us told us that you have 18 owned it since October of 2015. 19 You have also stated that you have tried to find a location. 20 You haven't found a 21 location. You are asking us for another two to three years to keep it in safekeeping. 22 What I'm

1 saying to you, even if the Board was to approve 2 that today, the -- we can only give you six So even if we were to do that today, we 3 months. 4 would approve it through October -- September 30, 5 2018. You also said to me today that you 6 7 have Mr. Shi who wants to buy the liquor license. 8 Okay. And that's why since he is here, I'm 9 saying to him okay, he wants to buy it, has he 10 been -- okay. Because you are a bus driver, you 11 haven't had time. You own a bus company. You 12 haven't had time. Is he going to find a 13 location? And so therefore, is he going to wait 14 another three years --15 MR. SHI: Huh-uh. 16 CHAIRPERSON ANDERSON: -- to try to find a location? 17 18 MR. WANG: Maybe he come. Maybe --19 CHAIRPERSON ANDERSON: No, but --20 MR. WANG: -- I'm not saying me. CHAIRPERSON ANDERSON: Well, that's 21 22 why I'm asking him. Now, if he said to me, okay,

1	I have identified a location. I am negotiating
2	with a landlord, then I mean, I would be more
3	inclined to say to the Board, you know, give him
4	some time to finalize the lease. But an A we
5	have a cap in the District of Columbia that you
6	can only have 250 A Licenses for the entire city.
7	We are almost at the cap. Okay? So
8	you are sitting on a very valuable license. So
9	why should this Board allow you to sit on a
10	license that someone else can utilize for another
11	three years, for another six months? That you
12	have had it for three years that you have not
13	used.
14	MR. ZHANG: Okay. April 4 in here I
15	buy the license. He told me that he you got
16	time. You take time for look at other location.
17	CHAIRPERSON ANDERSON: Yes. Yes, sir.
18	MR. ZHANG: Right?
19	CHAIRPERSON ANDERSON: Right.
20	MR. ZHANG: So I got it every year
21	we have had pay \$2,700 every year.
22	CHAIRPERSON ANDERSON: I know, sir,

1	yes.
2	MR. ZHANG: And I got a company, too.
3	I got a company too and before I cannot well,
4	D.C. Government
5	CHAIRPERSON ANDERSON: I know.
6	MR. ZHANG: the liquor store had
7	and company, too. I also got to check it out,
8	too. So you before told me you say you got time.
9	Okay. You just take no more since you hold
10	that the other lady, the old lady say that
11	October the 7th, it's I can't say one more year to
12	keep it there, the license.
13	CHAIRPERSON ANDERSON: Right.
14	MR. ZHANG: So I go check it out, too.
15	I go check it out many times and I got to work a
16	bus company, too. So just I got a little
17	right now, right now, I already no more time. I
18	got a bus with too many job, people work. So and
19	I check it out, check it out, check it out is
20	what I did. One, two, three, I got it just the
21	talk of time.
22	Someone tell me we don't have no time.

Well, my friend say, okay, he need it too. 1 Okay. 2 I for sale, that's it. Just what I want, what I need. 3 4 CHAIRPERSON ANDERSON: But you have to 5 decide do I want to own a liquor store or do I want to own a bus company or do --6 7 MR. ZHANG: Yes, I -- just I can't do 8 both, you know. 9 CHAIRPERSON ANDERSON: Because you are 10 telling me --MR. ZHANG: It's hard time. 11 12 CHAIRPERSON ANDERSON: But you are 13 telling me --14 MR. ZHANG: I can't have liquor store and buses. 15 16 CHAIRPERSON ANDERSON: Okay. But so 17 you are telling me that based on all the jobs you 18 had, you don't have time to run a liquor store. 19 MR. ZHANG: No. Yeah. 20 CHAIRPERSON ANDERSON: That's what you 21 are telling me. 22 MR. ZHANG: Before I driver, before I

1 already driver. Right now, I got a bus and --2 checking out store and location. Oh, I say very, very hard time. I say okay, well, maybe only one 3 deposit and I talk with my friend. Okay. 4 He 5 said okay, he need it. He got time, so forget 6 about --7 CHAIRPERSON ANDERSON: But he is not 8 telling me -- okay. Okay. You decide you're 9 going to pass it on to him. Uh-huh, uh-huh. 10 MR. ZHANG: 11 CHAIRPERSON ANDERSON: But he then 12 needs to tell me what is it that, okay -- all I found a location or I'm about to find a 13 right. 14 location and that -- and then once the location 15 is found, then you will formally ask that it's 16 transferred from you to him. 17 But basically, you are asking us to 18 put it back in safekeeping that even if you sell 19 it to him, he is going to sit on it for another 20 two to three years, that's what you are telling 21 me. 22 MR. ZHANG: Okay.

1	MR. SHI: No. If I have the license
2	change to my name, I will find a location to open
3	the liquor store.
4	CHAIRPERSON ANDERSON: So how long is
5	it going to take you to find if we were how
6	long is it going to take you to find a location
7	to open a liquor store?
8	MR. SHI: If I got a license, I will
9	try to as soon as I can find a good location to
10	open.
11	CHAIRPERSON ANDERSON: But, sir, you
12	have to tell us, you have to tell me, okay, I
13	have spotted these locations, okay? I have
14	spoken to these landlords to do it. Because
15	and so because it is now October it's now
16	it's March.
17	MEMBER SHORT: April.
18	CHAIRPERSON ANDERSON: It's April.
19	May, June, July, August, September, five months.
20	So even if we were to grant this today, would you
21	be able to identify a location in five months?
22	MR. SHI: I cannot tell you like

1

exactly, but I --

2	CHAIRPERSON ANDERSON: Would you be
3	able no, sir. Would you be able to identify a
4	location and actively be involved with a landlord
5	in five months? Because if the reason why I
6	said five months is because in October, you have
7	to come back again to us to ask for another six
8	months.
9	And so are you going to tell me that
10	he has had it for three years.
11	MEMBER SHORT: Mr. Chair is asking a
12	question.
13	CHAIRPERSON ANDERSON: Huh? Hold on.
14	I know. He has had it for three years. He
15	couldn't find he can't find a location in
16	three years. So therefore, if he sells it to
17	you, then you are going to sit on it another
18	three years and then you are going to come to us
19	and tell me
20	MR. SHI: Okay.
21	CHAIRPERSON ANDERSON: hold on,
22	sir. You have told me that you want to sell it
I	•

If you are going to -- you have told me 1 to him. 2 that you want to sell it to him. Okay. So because you told me you want to sell it to him, 3 4 if he can give me the answer that I need, it will 5 help your case, but he is basically -- you bought it from somebody who probably never used the 6 7 license. You are selling it for three years, now 8 you want to pass it on to him. He is going to 9 sit on it for another three years and then by the time -- and you see I don't care how much money 10 you sell it for to him, that's not our issue. 11 12 Our issue is that we want to make sure that someone -- that the license is available to 13 14 someone who is going to utilize it immediately, so the District can get -- sir, only -- sir, 15 16 everything is being transcribed by --17 unfortunately, you are speaking Mandarin Chinese 18 and I'm not sure if our transcriber speaks 19 Mandarin Chinese, so I'm not sure what is going 20 on with it, but both of us can't talk at the same 21 time. Okay? 22 But if you are talking to me, I need

you to either speak in English or I can reset 1 2 these proceedings, so I can get you a translator, so, therefore, we can communicate well. 3 MEMBER SHORT: Mr. Chairman? 4 CHAIRPERSON ANDERSON: All right. 5 Yes, Mr. Short? 6 7 MEMBER SHORT: I would just like to go 8 on the record and if anyone can dispute the 9 information I'm about to give, I wish they would. Our records here at ABRA show that the 10 License ABRA-15355, which is your license, has 11 12 been not operating since October 2009. 13 Is that true or untrue? No one has 14 operated and paid taxes from sales of alcohol to 15 the Washington, D.C. since 2009 when someone got 16 this license. 17 So now, we are just transferring it, 18 transferring and transferring and if I might say, 19 I'm just one Board Member, my thought is if that 20 license was in the hands of an operator who is 21 paying taxes in Washington, D.C., the fees you are paying once a year wouldn't touch that. 22

1	So someone could be operating with an
2	A License in Washington, D.C. and making it
3	benefit a community and benefit our tax base here
4	in Washington, D.C.
5	Do you keep have been in
6	safekeeping for three years and now want to sell
7	to someone else who doesn't know when they will
8	be able to operate with it and this has been
9	going on since 2009.
10	Why should we, as a Board, continue
11	this for you? What good reason do you have to
12	give us that we should continue the safekeeping
13	that you haven't used or no one has used since
14	2009? And here we are in 2018.
15	MR. WANG: The lady that bought it
16	from someone else, but we don't know there is
17	CHAIRPERSON ANDERSON: But she didn't
18	use it.
19	MR. WANG: Okay.
20	CHAIRPERSON ANDERSON: And then that's
21	what we're saying. She bought it from I don't
22	know when she bought it.

1	MR. WANG: Yeah.
2	CHAIRPERSON ANDERSON: Then she sold
3	it to
4	MR. WANG: Yeah, that's what we know
5	from there.
6	CHAIRPERSON ANDERSON: And I think,
7	sir, you know, I have been on this Board for two
8	years and your face is familiar to me. So you
9	have been here before. I am trying to figure it
10	out. It's going to come back to me and I
11	MR. ZHANG: Yeah, I know before here,
12	too, so I don't know what before you told me got
13	time, do more than several more years. I say I
14	can in several more years. I already know you
15	got a time. For new owner, you've got a time to
16	check out location.
17	CHAIRPERSON ANDERSON: Right, but
18	that's three but, sir, I understand. I
19	understand if I understand as a new owner,
20	you
21	MR. ZHANG: Yeah, you got time. New
22	owner got time

1	CHAIRPERSON ANDERSON: Yeah. But how
2	much time is reasonable?
3	MR. ZHANG: to check out
4	CHAIRPERSON ANDERSON: Tell me. Okay.
5	If I sell you something, what's a reasonable
6	period of time for you to start using it? You
7	tell me. What's reasonable? Tell me. What's
8	how what is reasonable?
9	MR. ZHANG: Okay. You say me got a
10	three year, you can say also when you sell my
11	friend, got three more year.
12	CHAIRPERSON ANDERSON: What's
13	reasonable?
14	MR. ZHANG: When I came early, hoping
15	to check out.
16	CHAIRPERSON ANDERSON: No. All right.
17	Okay. All right.
18	MR. ZHANG: Not the new owner, he
19	come to me and he got three years.
20	CHAIRPERSON ANDERSON: But this is
21	what I'm saying to you, okay? Okay. You tell me
22	what's reasonable? What is a reasonable period

1 of time for us to give you for you to finalize 2 it? What's reasonable? What six months, one 3 year, two years, three years, four years? You tell me what's reasonable. 4 5 MR. ZHANG: I make it early. Okay. 6 Maybe open everything. I make it -- I should buy 7 since I am the new owner, since I buy, I make it 8 early, open early. Sometime check it out, right 9 now got rent, sometime maybe \$6,000 the busy --10 yeah, right now they're busy before they're cheap 11 12 CHAIRPERSON ANDERSON: I'm thinking of 13 taking under advisement. 14 MR. ZHANG: Right now, the building go 15 high sometime, so, you know, check it out, check 16 it out, maybe he better. Maybe he a better. 17 Before me, to know he can open or not. He want 18 me to know. 19 CHAIRPERSON ANDERSON: All right. Mr. Shi? 20 21 MR. SHI: Yes, sir. If he was to --22 CHAIRPERSON ANDERSON:

if you were to buy the license from him --1 2 MR. SHI: Um-hum.. CHAIRPERSON ANDERSON: -- and if say 3 4 for example the Board says today --5 MR. ZHANG: Yeah, he no more than three years. Not say be three years. 6 7 CHAIRPERSON ANDERSON: I'm asking him. 8 I know so long, you know. MR. ZHANG: 9 CHAIRPERSON ANDERSON: If the Board 10 was to say, okay, fine, we will approve his request for safekeeping, how long would it take 11 12 you, how long would you want? Say for example we 13 approve his safekeeping request today, right? 14 MR. SHI: Um-hum. CHAIRPERSON ANDERSON: 15 You sign this 16 contract today and so you now have this license. 17 MR. SHI: Yes. 18 CHAIRPERSON ANDERSON: And so 19 therefore, in order for you to get the license, 20 you have to send in your documentation to us to 21 transfer to you. How long would it take you --22 MR. SHI: To find a location?

1 CHAIRPERSON ANDERSON: -- to find a 2 location to open up? Tell me how long. MR. SHI: How long? 3 I try to --4 CHAIRPERSON ANDERSON: No. I don't 5 want no try. You tell me how much time would it 6 take you to find a location to open to use this 7 license? 8 (Foreign language spoken) 9 CHAIRPERSON ANDERSON: Sir, sir, sir, 10 sir? Can you --11 MR. SHI: Okay. 12 CHAIRPERSON ANDERSON: -- if you want 13 me to hear, sir, because I have already told you 14 that I don't speak Mandarin Chinese, speak 15 English, because I know you can. I was going to 16 get you a translator, but by listening to you, I 17 now understand you clearly and I also know that 18 you understand me clearly, sir. 19 MR. SHI: Thank you. 20 CHAIRPERSON ANDERSON: So, please, 21 speak English. 22 MR. ZHANG: Okay.

1	CHAIRPERSON ANDERSON: So I can hear
2	what you are saying.

5	you, you told me that Mr. Shi wants to you are
6	going to sell it him. You gave me a sale

8	notarized yet, that you have your name is on

And then when we have a cap, then maybe you can sell it for -- you buy it for 10 11 \$25,000 and we have a cap, then you can sell it 12 for \$50,000. I don't know how much the first person 13 14 bought it for, but although that's not my I'm not going to say to you that --15 concern. 16 hey, if somebody wants to buy a liquor license 17 for \$100,000 and can hold it, that's another 18 issue. That's not mine. 19 What my issue is is that if you come 20 to us, you need to say to us genuinely I'm trying 21 to find a location. This is what I have done. 22 MR. SHI: Yes.
