The Alcoholic Beverage Control Board met in Alcoholic Beverage Control Hearing Room, Reeves Building, 2000 14th Street N.W., Washington, D.C., Ms. LaVerne Fletcher, Agent, presiding.

2 (10:32 a.m.)

3 AGENT FLETCHER: I'm calling the next
4 case now. The Roll Call Hearing for Players Club
5 is concluded. I'm now calling the case of French
6 75. Case Number 18-PRO-00004, ANB and Double H
7 LLC, 1400 14th Street NW, License Number ABRA-
8 108192. This is a retailer Class CT, new
9 application.

10 The protest issues are adverse impact
11 on peace, order and quiet, residential parking
12 and vehicular and pedestrian safety and real
13 property values.

14 I'm La Verne Fletcher, conducting this
15 Roll Call Hearing as the Board's Agent.
16 Introductions beginning with the applicant
17 please.

18 MS. FITCH: Candace Fitch, attorney
19 for the applicant.

20 AGENT FLETCHER: Ms. Fitch, would you
21 spell your name for the record please?

22 MS. FITCH: F as in Frank, I-T-C-H,

1 Candace, C-A-N-D-A-C-E.

2 AGENT FLETCHER: And Mr. Ian, would
3 you states your name and spell it again for the
4 record?

5 MR. HILTON: It's Ian, I-A-N, Hilton,
6 H-I-L-T-O-N.

7 AGENT FLETCHER: Thank you. And
8 present on behalf of ANC 2F?

9 MR. GUGGENMOS: It's John Guggenmos,
10 G-U-G-G-E-N-M-O-S, representing ANC 2F.

11 AGENT FLETCHER: Thank you and Mr.
12 Hillard, you're present on behalf of the group of
13 five?

14 MR. HILLARD: I am.

15 AGENT FLETCHER: If you would spell
16 your name for the record.

17 MR. HILLARD: Timothy Hillard, T-I-M-
18 O-T-H-Y, H-I-L-L-A-R-D.

19 AGENT FLETCHER: Are there any other
20 individuals present from your group today?

21 MR. HILLARD: There are not.

22 AGENT FLETCHER: Thank you.

1 Conditional standing is granted to your group of
2 five. Mr. Hillard, what that means is at that at
3 the upcoming status hearing, the other four
4 individuals would need to appear in person in
5 order for the board to grant full standing.
6 Otherwise, the board may dismiss the protest.

7 MS. FITCH: Ms. Fletcher, we also need
8 the protest letter from that.

9 AGENT FLETCHER: Okay. ANC 2F has
10 standing as a protestant. The date for the
11 status hearing is not available today. I'll give
12 you the date for the protest hearing and when you
13 receive the official hearing notice, the date of
14 the status hearing will be on it. The date for
15 the protest hearing is March the 28th. It's
16 March the 28th at 1:30. I'll give you the next
17 available date for mediation or did you want to
18 come on the same day as the other?

19 MR. GUGGENMOS: It's our preference
20 just to do it at the same time. We do feel we
21 have -- and we're going to reach an SA on Players
22 Club but just in case we don't.

1 AGENT FLETCHER: Right.

2 MR. GUGGENMOS: Can we do it at the
3 same time, is that fine?

4 AGENT FLETCHER: Yes. We can do one
5 right after the other. We can do 11:30 with
6 Players Club and when that's over, do French 75.

7 MR. GUGGENMOS: Thank you, Ms.
8 Fletcher.

9 AGENT FLETCHER: So I have French 75
10 to immediately follow Players Club. Any
11 questions at all? The roll call hearing is
12 concluded. Thank you.
