4	calendar is case number 19-AUD-00075 78, Fuel			
5	Pizza & Wings, license number 88727. Will the			
6	parties please approach and identify themselves			
7	for the record?			
8	MR. FACCI: Jason Facci on behalf of			
9	the District of Columbia.			
10	MEMBER ANDERSON: Mr. Facci.			
11	MS. STRAUSS: Good morning, Mr.			
12	Chairman. Paul Strauss on behalf of the			
13	establishment.			
14	MEMBER ANDERSON: Good morning. Who's			
15	with you, sir?			
16	MR. SMITH: Erinn Smith, General			
17	Manager of Fuel Pizza, K Street.			
18	MEMBER ANDERSON: Good morning, Mr.			
19	Smith. I'm sorry. Mr. Facci, is there any			
20	preliminary matters in this case?			
21	MR. FACCI: Yes, Mr. Chairman. We			
22	have an offer in compromise.			
23	MEMBER ANDERSON: And what's the offer			
24	in compromise, please?			
25	MR. FACCI: With respect to charge 1,			

a \$2,000 fine to be paid within 30 days or the 1 license shall be suspended indefinitely until the 2 3 fine is paid, and for the establishment to submit 4 all pending quarterly statements if they have not 5 already done so. MEMBER ANDERSON: Mr. Strauss, it's my 6 7 understanding that there's an offer in 8 compromise. And the offer in compromise is that 9 there is a fine of \$2,000 payable within 30 days. 10 If the fine is not payable within 30 days, the license will be suspended, and all 11 12 outstanding quarterly payments will be filed. Is 13 this your understanding of the offer in 14 compromise? 15 It is, Mr. Chairman. MS. STRAUSS: 16 MEMBER ANDERSON: Is your client aware 17 that by accepting the offer in compromise that 18 they've given up their right to a hearing? 19 MS. STRAUSS: They are. MEMBER ANDERSON: Your client is also 20 21 aware that by accepting the offer in compromise 22 that they're giving up their right to appeal this 23 matter? 24 They are, Mr. Chairman. MS. STRAUSS: 25 MEMBER ANDERSON: With that said, I

make a motion that the offer in compromise of a 1 fine of \$2,000 payable within 30 days be 2 3 accepted. If the fine is not paid within 30 4 5 days, the license will be suspended until the 6 fine has been paid and all outstanding quarterly payments will be filed. Is there a second? 7 8 MEMBER SHORT: Second. 9 MEMBER WAHABZADAH: Second. MEMBER ANDERSON: Mr. Short and Ms. 10 11 Wahabzadah second the motion. All those in 12 favor, say aye. 13 (Chorus of ayes) 14 MEMBER ANDERSON: Those opposed? The 15 matter passed 6-0-0. Thank you very much.
