On October 31, 2019, the Respondent paid the license fees for the period of 2019 to 2020 and the associated late fees.

It is hereby **ORDERED**, that the **ORDER TO CEASE AND DESIST** issued against BGS International, LLC, t/a Gee's Market, by the Board on October 23, 2019, pursuant to D.C. Official Code § 25-829 (2001), be and hereby is **VACATED**.

Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals on the motion.
