**ORDER ON SETTLEMENT AGREEMENT**

The Application filed by Georgetown Center, LLC, t/a Georgetown Social (Applicant), for a new on-premises retailer's license, class CR, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on August 6, 2018, in accordance with D.C. Official Code § 25-601 (2001).

The official records of the Board reflect that the Applicant, ANC 2E, and the CAG, have entered into a Settlement Agreement (Agreement), dated August 6, 2018, that governs the operation of the Applicant's establishment.


The Agreement has been reduced to writing and has been properly executed and filed with the Board. The Applicant; Lisa Palmer, on behalf of ANC 2E; and Pamela H. Moore, on behalf of the CAG, are signatories to the Agreement.


Accordingly, it is this 15<sup>th</sup> day of August 2018, **ORDERED** that:


1. The above-referenced Agreement submitted by the parties to govern the operations of the Applicant's establishment is **APPROVED** and **INCORPORATED** as part of this Order, except for the following modifications:
  - a. Section 3(b)(Noise) - The first sentence is amended to read as follows: "The Applicant shall comply with the District of Columbia's noise laws and regulations as set forth in the D.C. Official Code and the District of Columbia Municipal Regulations."
2. Copies of this Order shall be sent to the Applicant, ANC 2E, and the CAG.



Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, Reeves Center, 2000 14th Street, NW, 400S, Washington, D.C. 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR § 1719.1 stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
