19 before then. We just have to meet with our board
20 on Friday, so --

22 agree to.

23 MR. FIELDING: Okay.

24 MR. ANDERSON: But I am just saying,
25 if we are going to go to a full hearing, the

1 expectations is that we exchange documents and
2 witnesses seven days before the hearing.
