**ORDER APPROVING THE OFFER-IN-COMPROMISE**

---

This matter arises from a Notice of Status and Show Cause Hearing (Notice) issued by the Alcoholic Beverage Control Board (Board) in the matter of YDK, Inc., t/a Guilford Liquor (Respondent), located at 446 Rhode Island Avenue, NW, Washington, D.C. 20001.

The Alcoholic Beverage Regulation Administration (ABRA) served the Notice in Case No. 17-CC-00144 on the Respondent on April 4, 2018. *ABRA Show Cause File No. 17-CC-00144, Notice of Status and Show Cause Hearing (April 2, 2018)*. The Notice charges the Respondent with a single violation, which if proven true, would justify the imposition of a fine, as well as the suspension or revocation of the Respondent's license.

Specifically, the Notice in Case No. 17-CC-00144, charged the Respondent with the following violation:

Charge I: [On Saturday, December 16, 2017], [y]ou permitted the sale of an alcoholic beverage to a person under 21 years of age, in violation of D.C. Official Code § 25-781...

*ABRA Show Cause File No. 17-CC-00144, Notice of Status Hearing and Show Cause Hearing, 2-3 (April 2, 2018)*.

At the Show Cause Hearing held on May 2, 2018, the Respondent and the Government entered into an Offer-in-Compromise (OIC), which resolved the charge set forth above.

The terms of the OIC are as follows:

1. For Charge I – The Respondent shall pay a \$4,000 fine for the violation alleged in Charge I and shall have its license suspended for ten (10) days; with four (4) days served, and six (6) of those days stayed for one (1) year pending completion of alcohol awareness training for all employees who serve alcoholic beverages within ninety (90) days from the date of this Order.
2. In addition, the Respondent shall serve five (5) day suspension activated from Case No. 17-CC-00061.

By agreeing to the terms of the OIC, the Respondent hereby waives its right to a Show Cause Hearing and appeal. The OIC has been reduced to writing and is formally approved through this Order.

## **ORDER**

Therefore, the Board, on this 2nd day of May, 2018, hereby **APPROVES** the OIC proffered by the Government and the Respondent and **ORDERS** YDK, Inc., t/a Guilford Liquor, to comply with the terms of the OIC.

**IT IS FURTHER ORDERED** that the Respondent will:

- (1) Remit the fine in the total sum of \$4,000 payable on or before May 2, 2018;  
and
- (2) Incur a total of fifteen (15) day suspension, with nine (9) days served and six (6) days stayed for one (1) year pending completion of alcohol awareness training for all employees who serve alcoholic beverages within ninety (90) days from the date of this Order. The nine (9) day suspension will be served from May 21 through May 29, 2018.

Failure to remit the amount in full within the time specified will result in the suspension of the license until the amount is paid.

A copy of this Order shall be sent to the Respondent and to the Government.





Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
