8 MR. SOUSA: Christopher Sousa for the
9 District of Columbia.

10 CHAIRPERSON ANDERSON: Good morning,
11 Mr. Sousa.

12 MR. LIVELY: Keith Lively on behalf of
13 the licensee, Halftime Sports.

14 CHAIRPERSON ANDERSON: Good morning,
15 Mr. Lively. Have you made an appearance in this

17 MR. LIVELY: I'm with the Law Firm of
