113(a) and then once that is -- then there will 1 2 be a \$600 fine to be paid within 30 days or his license will be suspended until his fine is paid. 3 4 CHAIRPERSON ANDERSON: All right. Mr. 5 Brogan, do you have any objection to what was --MR. BROGAN: We accept the offer. 6 We ask that the Board submit the order today, so we 7 8 can pay on the spot. 9 CHAIRPERSON ANDERSON: All right. All 10 right. There are -- I just want to -- Ms. 11 Schmidt, there are actually two charges in this. 12 So is the Government --13 MS. SCHMIDT: Oh, I'm sorry. 14 CHAIRPERSON ANDERSON: -- dismissing 15 the second charge? 16 MS. SCHMIDT: Charge 2 is dismissed. 17 CHAIRPERSON ANDERSON: All right. 18 MS. SCHMIDT: I apologize. 19 CHAIRPERSON ANDERSON: All right. **All** 20 right. So, Mr. Brogan, it's my understanding 21 that -- well, the Government is asking to change 22 the statute and you say you don't have a problem

with that. You also stated that you are in 1 2 agreement with the \$600 fine for Charge 1 and that Charge 2 will be dismissed. And you are 3 4 stating that you will pay the fine today. IS 5 that correct? 6 MR. BROGAN: Yes, sir. 7 CHAIRPERSON ANDERSON: All right. With that said, I then make a motion that the 8 9 Offer in Compromise of a fine of \$600 for Charge 10 1 payable today, if the fine is not payable 11 today, the license will be suspended until the fine has been paid and that Charge 2 will be 12 13 dismissed. Is there a second? 14 MEMBER SHORT: Second. 15 CHAIRPERSON ANDERSON: Mr. Short has 16 seconded the motion. 17 All those in favor say aye. 18 ALL: Aye. 19 CHAIRPERSON ANDERSON: Those opposed? 20 The matter passed 6-0-0. Thank you very much. 21 Sir, I'll have you sign some papers 22 and then you can go and pay the fine.
