15	CHAIRPERSON ANDERSON: Mister? I'm

17	MR. BROGAN: Brogan, B-R-O-G-A-N.			
18	CHAIRPERSON ANDERSON: Good morning,			
19	Mr. Brogan.			
20	Mr. Sousa, are there any preliminary

10	today and that will be			
11	CHAIRPERSON ANDERSON: Okay.			
12	MR. SOUSA: yeah.			
13	CHAIRPERSON ANDERSON: All right. Mr.			
14	Brogan, it's my understanding that there is an			
15	Offer in Compromise and as you corrected the			
16	record, the Offer in Compromise is a fine of			
17	\$1,250 payable today. If the fine is not payable			
18	today, the license will be suspended.			
19	Is this your understanding, sir, of			
20	the Offer in Compromise?			
21	MR. BROGAN: Yes.			
22	CHAIRPERSON ANDERSON: Are you aware			

1	that by accepting an Offer in Compromise, you are
2	giving up your right to a hearing?
3	MR. BROGAN: Yes, sir.
4	CHAIRPERSON ANDERSON: And are you
5	also aware that by accepting an Offer in
6	Compromise, that you are giving up your right to
7	appeal this matter?
8	MR. BROGAN: Yes, sir.
9	CHAIRPERSON ANDERSON: With that said,
10	I then make a motion that the Offer in Compromise
11	of a fine of \$1,250 payable today be accepted.
12	If the fine is not payable today, the licensee
13	will be the license will be suspended until
14	the payment has been made. Is there a second?
15	MEMBER SHORT: Second.
16	CHAIRPERSON ANDERSON: Mr. Short has
17	seconded the motion.
18	All those in favor say aye.
19	ALL: Aye.
20	CHAIRPERSON ANDERSON: Those opposed?
21	The matter passes 5-0-0.
22	MR. BROGAN: Thank you.
