**ORDER ON DISMISSAL OF THE GROUP OF FIVE  
INDIVIDUALS’ PROTEST**

The Application filed by 1336 U Street, LLC, t/a Hawthorne, to Terminate Settlement Agreement for its Retailer’s Class CT License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on December 23, 2019, in accordance with D.C. Official Code § 25-601 (2001).

On December 23, 2019, the Board dismissed the Protest of the Group of Five Individuals because all group members failed to sign the protest letter. Under 23 DCMR § 1602.3, all protests shall be signed by the protestant and contain the protestant’s full name and mailing address. *See also* 23 DCMR § 1801.2(f) (requiring that the printed name and address of each petitioner, accompanied by his or her handwritten signature).

The Group of Five Individuals may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order.

## **ORDER**



Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
