15 No. 99569.

17 identify themselves for the record, please?

18 MS. PHILLIPS: I'm sorry, what did you  
19 say the case number was?

20 CHAIRPERSON ANDERSON: Case No. 17-  
21 CMP-00571.

22 MS. PHILLIPS: Thank you.

1                   CHAIRPERSON ANDERSON: Imm on H. Will  
2 the parties, please, approach? License No.  
3 99569. Will the parties, please, approach and  
4 identify themselves for the record, please?

5                   MS. PATSY-SUTA: Hi. My name is  
6 Kujong Patsy-Suta. I came from behalf of the  
7 owner.

8                   CHAIRPERSON ANDERSON: And who are  
9 you? Do you have -- did they provide you with  
10 something in writing saying that you can  
11 represent them in these proceedings today?

12                  MS. PATSY-SUTA: Actually, I just come  
13 and take the case today.

14                  CHAIRPERSON ANDERSON: I don't -- so  
15 you said you came on behalf of the owner. What  
16 do you mean? You just -- they just asked you to  
17 show up?

18                  MS. PATSY-SUTA: Yes.

19                  CHAIRPERSON ANDERSON: Did they give  
20 you something in writing to say that you can show  
21 up today to represent them?

16                  At the hearing on June 20th at 2:30, if  
17      the owner is not here, if you are the person who  
18      is going to show up, you need to bring something  
19      on the letterhead where they specifically give  
20      you something in writing to be here to represent  
21      the licensee.

22                  MS. PATSY-SUTA: Okay.

1                   CHAIRPERSON ANDERSON: So if the owner  
2 is not going to be here in-person or if they --  
3 or you can let the owner know that if they are  
4 not going to be here in-person, if they are going  
5 to send someone to represent them, if the person  
6 is not an attorney, then they need to send  
7 something in writing to say this person is  
8 authorized to represent us. Okay?

9                   MS. PATSY-SUTA: Okay.

10                  CHAIRPERSON ANDERSON: All right. So  
11 June 20th. So June 20th at 2:30 p.m. All right.  
12 Thank you.

13                  The Board is in recess until our 1:30  
14 hearing. Okay. All right. Thank you.
