#### ORDER ON AMENDMENT TO COOPERATIVE AGREEMENT


The official records of the Alcoholic Beverage Control Board (Board) reflect that Carr Wharf 3B Hotel Lessee, LLC, t/a InterContinental Washington D.C.—The Wharf/Moon Rabbit (Licensee), and ANC 6D entered into a Cooperative Agreement (Agreement), dated July 10, 2017, that governs the operations of the Licensee's establishment. This matter comes now before the Board to consider the Parties' Amendment to Cooperative Agreement (Amendment), dated July 21, 2021, in accordance with D.C. Official Code § 25-446 (2001).

The Amendment has been reduced to writing and has been properly executed and filed with the Board. The Licensee and Chairperson Edward Daniels, on behalf of ANC 6D, are signatories to the Amendment.

Accordingly, it is this 28th day of July 2021, **ORDERED** that:

- 1. The above-referenced Amendment to Cooperative Agreement submitted by the Parties to govern the operations of the Licensee's establishment is **APPROVED** and **INCORPORATED** as part of this Order;
- 2. All terms and conditions of the original Agreement, not amended by the Amendment, shall remain in full force and effect; and
- 3. Copies of this Order shall be sent to the Licensee and ANC 6D.

However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. #### FIRST AMENDMENT TO COOPERATIVE AGREEMENT

THIS AMENDMENT #1 to the COOPERATIVE AGREEMENT ("Agreement") is made on this 12th day of July 2021 by and between Carr-Wharf 3B Hotel Lessee LLC t/a Intercontinental Washington D.C. - The Wharf / Moon Rabbit ("Licensee"), at 801 Wharf Street, SW, Washington, DC 20024, ABRA License #114491, and Advisory Neighborhood Commission 6D ("the ANC"), (collectively, the "Parties"). This amendment updates the Agreement dated July 10, 2017 and finalized by ABC Board Order 2017-398 dated July 19, 2017.

#### RECITALS

WHEREAS, the original licensee, Carr Waterfront Hotel LLC, and ANC 6D entered into a new Cooperative Agreement dated July 10, 2017 for an establishment ("Establishment") at 801 Wharf Street, SW, Washington, DC 20024 for ABRA License #106688;

WHEREAS, the ABC Board approved a transfer of Carr Waterfront Hotel LLC's Retailer's Class C Hotel ABC License (ABRA-106688) to Licensee on a no substantial change basis in July 2019, and ABC Board Order 2017-398 remains in effect for the ABC License at the Establishment;

WHEREAS, the Retailer's Class C Hotel ABC License (ABRA-114491) was issued to Licensee for the Establishment in September 2019; and

WHEREAS, the original Cooperative Agreement dated July 10, 2017 provided for the following Floors Utilized and Occupancy:

"The Applicant will operate the 24-hour Hotel Establishment with 278 guest rooms, dining facilities, and two summer gardens. The Certificate of Occupancy will state the maximum room count and summer garden seating capacities; however, the Establishment shall not exceed the total occupancy load of 2.27 patrons in the dining room and 72 and 40 seats respectively in the two summer gardens."

WHEREAS, Licensee would like to add an additional summer garden endorsement to its ABC License for a third summer garden located on the ground floor;

WHEREAS, the Parties request that the Alcoholic Beverage Control Board approve this Amendment to Cooperative Agreement conditioned upon the Licensee's compliance with the terms of this written Amendment and the previously executed Cooperative Agreement and Board Order and ABC License; and

NOW, THEREFORE, in consideration of the recitals set forth above, it is mutually understood and agreed by and between the undersigned Parties to amend the previously executed Agreement as follows:

 Recitals Incorporated. The recitals set forth above are incorporated herein by reference. 2.-Paragraph-2; "Nature-of-the-Business;" first sentence is stricken and replaced in its entirety by the following:

"The Applicant will manage and operate a Hotel Establishment including a full-service restaurant serving spirits, wine, and beer, with three Summer Gardens, and entertainment and dancing endorsements in the indoor space.

3. Paragraph 3, "Floors Utilized and Occupancy," section is stricken entirely and replaced by the following:

"The Applicant will operate the 24-hour Hotel Establishment with 278 guest rooms, dining facilities, and three Summer Gardens. The Certificate of Occupancy will state the maximum room count and Summer Garden capacities; however, the Establishment shall not exceed the total occupancy load of 227 patrons in the dining room; and 72 seats on the rooftop Summer Garden, 61 seats on the first-floor summer garden adjacent to the restaurant, and 40 seats on the other first-floor Summer Garden."

4. Paragraph 4, "Hours of Operation, Sales, Service, Consumption, and Entertainment," fourth sentence stricken entirely and replaced with the following:

"The hours of selling, serving, and consuming alcohol in the three Summer Gardens shall be: Sunday through Saturday: 11:00 a.m. to 12:00 a.m."

5. Paragraph 4, "Hours of Operation, Sales, Service, Consumption, and Entertainment," is further amended by striking the last sentence of Paragraph 4 and replacing it with the following:

"Sales of Alcoholic Beverages: Applicant shall not sell liquor, beer or wine from the Premises primarily intended for off-Premises use except as permitted by DC law and regulations. Unfinished/recorked bottles of wine are allowed to be removed from the Premises."

 Agreement Otherwise Unamended. Except as otherwise provided herein, the terms and conditions of the previously executed Cooperative Agreement, Board Order, and License are expressly reaffirmed and remain in full force and effect.
