There is a single 13 14 charge of the establishment operating after its 15 approved hours. 16 So to resolve that charge, the parties 17 are willing to make an Offer in Compromise in 18 which the establishment pays a fine in the amount 19 of \$1,250 to be paid in 45 days. And if the establishment does not pay the fine within the 45 20 21 day period, it understands that its license can--22 will be suspended indefinitely until the fine is
