MR. BUTLER: Good morning. I'm James Butler, J-A-M-E-S B-U-T-L-E-R, one of the protestants here. It appears that the applicant has not shown up.

But if at some point in the future he is granted reinstatement, I'm going to dismiss the application in a minute -- at some point, if he's granted a reinstatement, there's going to be a status hearing.

If there is one, at least four more people that are not here today need to appear inperson. The Board needs to see at least five faces. So you're here today. You count as one. We would need to see four more people from that group.

And just for the record, there were two names on your protest letter that are not legible. So I can't address those two. But for the names that I could read, there are six of you, which is sufficient.

MR. BUTLER: That's correct.

MS. FLETCHER: Okay, so I'm granting conditional standing to six. The applicant is

24	MS. FLETCHER: Do you have any today?
