4	everyone. We're back on the record. Welcome to
5	the afternoon session of the ABC Board.
6	My name is Donovan Anderson. I'm
7	Chairman of the Board. We're joined this
8	afternoon by Mr. James Short, Mr. Bobby Cato, Ms.
9	Rafi Crockett, Ms. Jeni Hansen, Mr. Edward
10	Grandis. The Board has six members in attendance
11	today and that constitutes a quorum.
12	We have two hearings on our afternoon
13	calendar, a fact finding hearing and a protest
14	hearing. I know that this hearing was supposed
15	to started at 1:30. The first hearing, we have
