The Applicant is on this side and the Protestant 6 7 is on this side, thank you. 8 Johana's Inc, 4728 14th Street, NW, 9 License Number ABRA-25996. This is a Retailer 10 Class CT License Renewal. The protest issues are 11 adverse impact on peace, order and quiet, 12 residential parking and vehicular and pedestrian 13 safety and real property values. 14 My name is LaVerne Fletcher, 15 conducting the roll call hearing as the Board's 16 agent. JONES: My name is Douglas Jones, 20 D-O-U-G-L-A-S, Jones, J-O-N-E-S. 21 MS. FLETCHER: Thank you, Mr. Jones. 22 And present on behalf of ANC 4C. 23 MS. BARRY: Yes. My name is Maria

Barry, B-A-R-R-Y. And I'm Commissioner, 4C02.
