ORDER ON DISMISSAL OF PROTESTS

The Application filed by Asmara Incorporated, t/a Kenilworth Market (Applicant), for renewal of its Retailer's Class A License, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on May 29, 2018, in accordance with D.C. Official Code § 25-601 (2001).

On May 29, 2018, the Board dismissed the Protests of Eastland Garden Civic Association and the Group of Five or More Individuals.

Eastland Garden Civic Association's Protest was dismissed because Eastland Garden Civic Association did not give the Applicant at least seven (7) days advanced notice of the Eastland Garden Civic Association meeting, pursuant to D.C. Official Code § ,25-601(3)(B).

The Group of Five or More Individuals' Protest was dismissed because only Sheila Gear-Israel and Rochelle Gray, who also represented Cindy A. Hamilton, were present at the Roll Call Hearing and at least two more individuals must appear at the hearing to be granted standing as A Group of Five or More Individuals, pursuant to Title 23 DCMR § 1602.3.

Eastland Garden Civic Association and the Group of Five or More Individuals may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order.

ORDER

The Board does hereby, this 6th day of June, 2018, **DISMISS** the Protests of Eastland Garden Civic Association and the Group of Five or More Individuals. Copies of this Order shall be sent to the Applicant; Rochelle Gray, on behalf of Eastland Garden Civic Association; and the Group of Five or More Individuals.

However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion.
