CHAIRPERSON ANDERSON: The next case on our calendar is Case No. 19-PRO-00139, Kiss Tavern, License No. 104710. I will now take a moment for our IT specialist to elevate the rights of each party at this stage to enable their camera and microphone. Ms. Andrews, can you please elevate the rights of Mr. Bianco who is, it's my understanding, the attorney for the licensee and also I believe Anita Norman, ANC 1B representative, please.

MS. ANDREWS: Both parties have been -- their rights have been elevated.

CHAIRPERSON ANDERSON: Thank you very much. Ms. Norman, can you please enable your camera, please, if you're able to do that?

9 CHAIRPERSON ANDERSON: You can make a
10 motion now to withdraw and we will withdraw it.
11 So if that's what you want us to do so we can --
12 you can put it on the record. Or do you want to
13 do it in writing?

14 MS. NORMAN: No, on the record is
15 fine. I move to withdraw the protest against
16 Kiss Tavern.

17 CHAIRPERSON ANDERSON: Do you have an
18 objection to that, Mr. Bianco?

19 MR. BIANCO: I do not, Mr. Chair, the
20 licensee's defense.

21 CHAIRPERSON ANDERSON: All right.
22 Well, thank you very much, Ms. Norman. Thank
23 you, Mr. Bianco. The protest is being withdrawn
24 -- has been withdrawn by the ANC. And the Agency
25 will move forward towards renewing the license --

1 the Agency will move forward in following the
2 process for renewing of the licence.

3 I'm sorry. Hold on one minute,
4 please. So the Agency will move forward towards
5 the -- well, basically, where we are now is that
6 the licensee will follow the process towards
7 renewing the license. All right. So thank you
8 very much. Have a great day. All right.

9 MS. NORMAN: Thank you.
