16	MR. WOOD: I'm the hotel manager.
17	CHAIRPERSON ANDERSON: Do you have a
18	Letter of Authorization?
19	MR. WOOD: I do.
20	CHAIRPERSON ANDERSON: You can give
21	that to her, please. And your well, wait
22	until I get this. Thank you.

1	All right. Mr. Sousa, is there any		
2	preliminary matters in this case?		
3	MR. SOUSA: There is		
4	CHAIRPERSON ANDERSON: And what's		
5	that, sir?		
6	MR. SOUSA: an OIC to present to		
7	the Board.		
8	CHAIRPERSON ANDERSON: And what's

10	MR. SOUSA: The OIC for Charge No. 1		
11	is the charge is failing to keep an ABC		
12	Manager on Duty during the licensed hours of		
13	sales and the OIC agreed to is \$1,250 to be paid		
14	within 30 days or the license will be suspended		
15	indefinitely.		
16	Charge No. 2 is another ABC Board		
17	Manager violation, that has been agreed to be		
18	dismissed.		
19	CHAIRPERSON ANDERSON: All right.		
20	Thank you. Hello, Mr. Wood, again.		
21	MR. WOOD: Hi, good morning.		
22	CHAIRPERSON ANDERSON: It's my		

1 understanding that there is an Offer in 2 Compromise and the Offer in Compromise is that there is a fine of \$1,250 payable in 30 days. 3 4 Is this your understanding, sir, of 5 the Offer in Compromise? 6 MR. WOOD: Yes. 7 CHAIRPERSON ANDERSON: Are you aware 8 that by accepting an Offer in Compromise, that 9 you are giving up your right to a hearing? MR. WOOD: Yes. 16 CHAIRPERSON ANDERSON: All right. 17 With that said, I then make a motion that the 18 Offer in Compromise of a fine of \$1,250 payable 19 in 30 days, if the fine is not payable in 30 20 days, the license will be suspended. Is there a 21 second? 22 MEMBER SHORT: Second.
