1 that, sir? 2 MR. RIVERO: The offer consists of, for Charge 1 dismissal of the charge. 3 4 CHAIRPERSON ANDERSON: Yes. MR. RIVERO: For Charge 2 a fine of 5 6 \$850 dollars payable within 30 days. And if the 7 fine is not paid within 30 days the license will 8 be suspended until the payment is received. That 9 is the offer in compromise. All right. 10 CHAIRPERSON ANDERSON: 11 Mr. Amaya, it's my understanding that Thank you. 12 there's an offer in compromise, sir.
