4	next case on our calendar is Case No. 18-CIT-
5	00092, La Villa Café, License No. 94826.
6	Would the parties, please, approach
7	and identify themselves for the record, please?
8	MR. RIVERO: Good morning, Board
9	Members. Fernando Rivero for the District of
10	Columbia standing in for Assistant Attorney
11	General Schmidt.
12	CHAIRPERSON ANDERSON: Good morning,
13	Mr. Rivero.
14	MR. AMAYA: Good morning. My name is
15	Isidoro Amaya, I-S-I-D-O-R-O A-M-A-Y-A. I'm one
16	of the owners of La Villa Café.
17	CHAIRPERSON ANDERSON: Good morning,
18	Mr. Amaya.
19	Are there any preliminary matters in
20	this case?
21	MR. RIVERO: Yes, Board Members, the
22	parties have an Offer in Compromise to present to

	the Board, at this time.
2	CHAIRPERSON ANDERSON: And what is
3	that, sir?
4	MR. RIVERO: The offer consists of a
5	fine of \$850 payable in 30 days. And if the fine
6	is not paid in 30 days, the license will be
7	suspended until payment is received. That is the
8	offer.
9	CHAIRPERSON ANDERSON: Thank you. Mr.
10	Amaya, it is my understanding there is an Offer
11	in Compromise and the Offer in Compromise is that
12	there is a fine of \$850 payable in 30 days. If
13	the fine is not payable in 30 days, the license
14	will be suspended until the fine has been paid.
15	Is this your understanding, sir, of
16	the Offer in Compromise?
17	MR. AMAYA: Yes, Mr. Chairman.
18	CHAIRPERSON ANDERSON: Are you aware
19	that by accepting an Offer in Compromise, that
20	you are giving up your right to a hearing?
21	MR. AMAYA: Yes.
22	CHAIRPERSON ANDERSON: Are you also

aware that by accepting an Offer in Compromise, 1 2 that you are giving up your right to appeal this matter? 3 4 MR. AMAYA: Yes. 5 CHAIRPERSON ANDERSON: With that said, I then make a motion that the Offer in Compromise 6 7 of a fine of \$850 payable in 30 days be accepted. 8 If the fine is not paid in 30 days, the license 9 will be suspended until the fine has been paid. Is there a second? 10 11 MEMBER SHORT: Second. 12 CHAIRPERSON ANDERSON: Mr. Short has seconded the motion. 13 14 All those in favor say aye. 15 ALL: Aye. 16 CHAIRPERSON ANDERSON: All those 17 opposed? The matter passes 6-0-0. 18 I want to thank the parties for 19 working this matter out. 20 And, Mr. Amaya, we have some 21 documentation for you to sign and it's 30 days 22 from today, sir. Thank you very much.
