3 CHAIRPERSON ANDERSON: What I'm going
4 to do is that let me move on to our -- and I'm
5 only doing this because I have to recall two
6 cases, so I'm going to move on to the other
7 calendar, but I will recall the Protest Hearing
8 (Status) shortly.

9 So let's move on to the Show Cause
10 Hearing (Statu) Calendar. The first case on our
11 Show Cause Hearing (Status) Calendar is Case No.
12 18-CIT-00091, La Villa Café, License No. 94826.

13 Will the parties for La Villa Café,
14 please, appear and identify yourself for the
15 record, please.

16 MS. SCHMIDT: Good morning, Amy
17 Schmidt, Assistant Attorney General on behalf of
18 the District of Columbia.

19 CHAIRPERSON ANDERSON: Good morning,
20 Ms. Schmidt.

21 MR. AMAYA: Good morning. I'm Isidoro
22 Amaya, the owner of La Villa Café.

1 CHAIRPERSON ANDERSON: Good morning,
2 Mr. Amaya. Could you make sure -- there is a
3 sign-in sheet, can you, please, sign-in your name
4 for the record, please?

5 MR. AMAYA: Thank you.

6 CHAIRPERSON ANDERSON: Ms. Schmidt,
7 are there any preliminary matters in this case?

8 MS. SCHMIDT: Yes. Yes, there is.
9 There is an Offer in Compromise which consists of
10 the establishment paying an \$800 fine to be paid
11 within 30 days and if it's not paid within 30
12 days, this license will be suspended until the
13 fine is paid.

14 CHAIRPERSON ANDERSON: Mr. Amaya, it's
15 my understanding that there is an Offer in
16 Compromise and the Offer in Compromise is a fine
17 of \$800 payable in 30 days. If the fine is not
18 payable in 30 days, your license will be
19 suspended until the fine is paid.

20 Is this your understanding, sir, of
21 the Offer in Compromise?

22 MR. AMAYA: Yes.

1 CHAIRPERSON ANDERSON: Are you aware
2 that by accepting an Offer in Compromise, that
3 you are giving up your right to a hearing?

4 MR. AMAYA: Yes.

5 CHAIRPERSON ANDERSON: Are you also
6 aware that by accepting an Offer in Compromise,
7 that you are giving up your right to appeal this
8 matter?

9 MR. AMAYA: Yes.

10 CHAIRPERSON ANDERSON: All right.
11 Hearing that, I then make a motion that the Offer
12 in Compromise of a fine of \$800 payable in 30
13 days, if the fine is not payable in 30 days, the
14 license will be suspended until the fine is paid.
15 Is there a second?

16 MEMBER SHORT: Second.

17 CHAIRPERSON ANDERSON: Mr. Short has
18 seconded the motion.

19 All those in favor say aye.

20 ALL: Aye.

21 CHAIRPERSON ANDERSON: Those opposed?

22 The matter passes 6-0-0.

1 We will have you sign-off on this
2 matter, sir.

3 MS. SCHMIDT: Thank you.

4 CHAIRPERSON ANDERSON: All right.

5 MR. AMAYA: Thank you.

6 CHAIRPERSON ANDERSON: All right.

7 Yes, thank you. Sign the document, sir, please.

8 (Whereupon, the Show Cause (Status)
