3 CHAIRPERSON ANDERSON: The next case
4 is Case Number 19-AUD-00084, Le Desales, License
5 Number 60754. Will the parties please approach
6 and identify themselves for the record, please.

7 MR. UDDIN: Good morning, sir. This
8 is Muhammad Uddin. I'm representing Café Europa.

9 CHAIRPERSON ANDERSON: What's your
10 last name, sir?

11 MR. UDDIN: Uddin, U-D-D-I-N.

19 o'clock. March the 11th at 11 o'clock. All
20 right. Thanks.
