3 CHAIRPERSON ANDERSON: Our next case  
4 is case number 19-AUD-00084 LeDesales, license  
5 number 60754.

6 Will the parties please approach and  
7 identify themselves for the record, please?

8 MR. FACCI: Mr. Chairman, members of  
9 the Board, Jason Facci on behalf of District of  
10 Columbia.

11 CHAIRPERSON ANDERSON: Mr. Facci.

12 This matter is scheduled for a show  
13 cause hearing. Is there any preliminary matter?

14 MR. FACCI: Yes, Mr. Chairman. We do  
15 have an offer in compromise.

16 CHAIRPERSON ANDERSON: And what is  
17 that, sir?

18 MR. FACCI: Regarding charge 1, a two-  
19 thousand-dollar fine to be paid within 30 days or  
20 the license shall be suspended --

21 CHAIRPERSON ANDERSON: I'm sorry.  
22 Before, I didn't have you guys introduce  
23 yourselves. I apologize.

24 MR. UDDIN: This is Muhamed Uddin, on  
25 behalf of DeSales.

1 CHAIRPERSON ANDERSON: And what's your  
2 -- what's your -- what --

3 MR. UDDIN: My position is accounts  
4 payable. So I have the letter. I came here last  
5 time. And so the -- the owner --

6 CHAIRPERSON ANDERSON: Yeah. Can --  
7 can we have that, please?

8 MR. UDDIN: Definitely, sir.

9 CHAIRPERSON ANDERSON: Can you write  
10 in -- there's a sign-in sheet there. Can you --

11 MR. UDDIN: Yes, sir.

12 CHAIRPERSON ANDERSON: Yeah, please.

13 MR. UDDIN: Definitely.

14 CHAIRPERSON ANDERSON: Anyway, all  
15 right. Is there a preliminary matter?

16 MR. FACCI: Yes, Mr. Chairman. We  
17 have an offer in compromise.

18 CHAIRPERSON ANDERSON: And what is  
19 that, please?

20 MR. FACCI: With respect to charge 1,  
21 a two-thousand-dollar fine to be paid within 30  
22 days or the license shall be suspended  
23 indefinitely until the fine is paid, and for the  
24 establishment to submit all pending quarterly  
25 statements if they have not already done so.

1 CHAIRPERSON ANDERSON: Mr. Uddin?

2 MR. UDDIN: Yes, sir.

3 CHAIRPERSON ANDERSON: Uddin.

4 MR. UDDIN: Yes, sir.

5 CHAIRPERSON ANDERSON: All right. It  
6 -- it is my understanding that there is a -- an  
7 offer in compromise. And the offer in compromise  
8 is that there is a fine of \$2,000 payable within  
9 30 days. If the fine is not paid within 30 days,  
10 the license will be suspended until the fine has  
11 been paid, and that if the quarterly statements  
12 have not been filed, that all outstanding  
13 quarterly statements must be provided.

14 Is this your understanding of the  
15 offer in compromises?

16 MR. UDDIN: Yes, Chairman.

17 CHAIRPERSON ANDERSON: Is your -- are  
18 you aware that by accepting an offer in  
19 compromise, that you're giving up your right to a  
20 hearing?

21 MR. UDDIN: Yes.

22 CHAIRPERSON ANDERSON: Are you also  
23 aware that by accepting an offer in compromise,  
24 that you're giving up your right to appeal this  
25 matter?

1 MR. UDDIN: Yes.

2 CHAIRPERSON ANDERSON: With this,  
3 then, I make a motion that the offer in  
4 compromise of a fine of \$2,000 payable within 30  
5 days be accepted, that if the fine is not paid  
6 within 30 days, the license will be suspended  
7 until the fine has been paid, secondly that all  
8 outstanding -- as part of the first charge, that  
9 if there's any outstanding quarterly payments,  
10 that they be submitted immediately.

11 Is there a second?

12 MEMBER CROCKETT: Second.

13 MEMBER SHORT: Second.

14 CHAIRPERSON ANDERSON: Mr. Short and  
15 Ms. Crockett have seconded the motion. All those  
16 in favor say aye.

17 (Chorus of aye.)

18 CHAIRPERSON ANDERSON: Those opposed?

19 The matter passes, seven-zero-zero.

20 Thank you. I'll have you sign off on this  
21 paperwork, sir.

22 All right. Thank you. The Board is  
23 in recess until our 1:30 hearing.

24 (Whereupon, the above-entitled matter  
25 went off the record at 11:08 a.m.)
