know there are a series of applications that you had filed and so let us know regarding -- let us know about the events that you had requested.

Are you still planning to have all these events?

And once you give an answer, then we might have some other additional questions for you.

MR. WITT: Yes, sir. So originally, I had applied for a one-day permit for April 6th as well as the remaining game days at Audi Field for 151 T Street; the Akridge Parking Lot, I would like to withdraw those applications.

CHAIRPERSON ANDERSON: Which ones?

The one for April the 6th 1 MR. WITT: 2 and then the ones for all corresponding dates after. 3 4 CHAIRPERSON ANDERSON: So you are 5 withdrawing all the applications? For that specific area, 6 MR. WITT: 7 yes, sir. 8 CHAIRPERSON ANDERSON: Okay. 9 MR. WITT: Our partner DC United cannot come to terms with the Akridge Parking Lot 10 11 on properly operating the space. We are the food 12 and beverage provider for DC United and so they had asked us to move forward with applications 13 14 for that space for pre-game activities, but since we cannot come to a resolution with Akridge 15 16 Parking Lot, formerly where the Field House was, 17 we are no longer interested in operating that 18 space and would like to withdraw the application 19 for April 6th as well as all corresponding dates 20 after, which will be 15 dates.
