ORDER GRANTING WITHDRAWAL OF PROTEST

Lidl US Operations, LLC, t/a Lidl, (Applicant) filed an Application for a Substantial Change to its Retailer's Class A License. The license was protested by Advisory Neighborhood Commission (ANC) 7B. The Applicant filed a motion to dismiss arguing that the ANC's stated grounds for the protest was not approved at the appropriate ANC meeting as required by law; therefore, the ANC failed to state an appropriate objection and should be dismissed. *Mot. to Dismiss*, at 1. The ANC opposed the motion and the parties made oral arguments before the

Board. After oral arguments, the ANC filed a motion to withdraw the protest, which the Board grants.

ORDER

For these reasons, on this 19th day of October 2022, the Board **GRANTS** the withdrawal of the protest of ANC 7B. All pending motions are deemed **MOOT**. A copy of this Order shall be provided to the parties.

Official Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202-879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR § 1719.1 stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
