8	MR. RIVERO: Good morning, Board
9	Members. Fernando Rivero for the District of
10	Columbia.
11	CHAIRPERSON ANDERSON: Good morning,
12	Mr. Rivero.
13	MR. MIRZADEH: Farhad Mirzadeh for
14	Lupo Verde.
15	CHAIRPERSON ANDERSON: Good your
16	last again, sir?
17	MR. MIRZADEH: Mirzadeh.
18	CHAIRPERSON ANDERSON: Mirzadeh? Are
19	you an attorney, sir?
20	MR. MIRZADEH: No, I'm not.
21	CHAIRPERSON ANDERSON: What's your
22	role in representing?

2	agent for the restaurant.
3	CHAIRPERSON ANDERSON: Hold on.
4	MR. MIRZADEH: I submitted the form
5	just a few minutes ago.
6	CHAIRPERSON ANDERSON: Okay. All
7	right. All right. I just wasn't aware, so
8	that's one of the reasons why I asked you.
9	MR. MIRZADEH: Yes.
10	CHAIRPERSON ANDERSON: So do we have
11	information that Mr. Mirzadeh who did you
12	provide it to, sir? I need because if you are
13	an attorney, then I'm fine with that, but if you
14	are not an attorney, I need something to say that
15	you are authorized to represent
16	MR. MIRZADEH: Right. Can I go grab
17	it real quick?
18	CHAIRPERSON ANDERSON: Sure, yeah.
19	Who was it given to?
20	MR. MIRZADEH: To a clerk here. I
21	think it was oh, it's right here. The Clerk
22	of the Court.

1	CHAIRPERSON ANDERSON: All right. Mr.
2	Mirzadeh, good morning, sir. As far as the
3	formality, it's
4	MR. RIVERO: Can I have a copy for my
5	file?
6	CHAIRPERSON ANDERSON: Well, I think,
7	with all due respect, sir, you need to show it to
8	the Government, too, so the Government will know
9	that your representation, especially this is a
10	full this is supposed to be a full hearing,
11	so
12	MR. MIRZADEH: I appreciate the
13	Board
14	CHAIRPERSON ANDERSON: I want to
15	make sure that whatever decision is made today,
16	someone can't say that I did not authorize this
17	person to represent us today. And so I want to
18	make sure that when you are an attorney, it's
19	much easier, because I know that at least we
20	report to a higher order.
21	So I have some recourse I can take if
22	someone comes in and says I'm an attorney and I

represent an establishment, but if you are not an 1 2 attorney, then there is not -- I don't have any options once you leave here. So that's -- it's 3 4 just a formality. So we will provide Mr. Rivero 5 with your authorization. This is a full Show Cause Hearing. 6 Are there any preliminary matters in this case? 7 8 MR. RIVERO: Yes. 9 CHAIRPERSON ANDERSON: And what is 10 that, Mr. Rivero? 11 The preliminary matter MR. RIVERO: 12 before the Board today is the Government's Motion to Dismiss this case. And the basis for that 13 14 motion, at this time, is insufficient evidence to move forward to prove by a preponderance of the 15 16 evidence that there has been a violation of Title 17 25 as the Government has alleged in its Notice to 18 Show Cause. 19 The investigative report, which is a 20 part of the Agency file and which I presume you 21 have before you, has its own exhibits. 22 And Exhibit No. 4 of that report is

the settlement agreement that is the issue in 1 2 this case. That settlement agreement has Mr. Ferris as a party to that agreement. 3 Mr. Ferris 4 was the complainant in this case that generated 5 the investigation. And so he is a signatory. Paragraph 12 of that agreement is what 6 I would call a cure provision, which directs how 7 8 the settlement agreement will be enforced, but it 9 indicates that in the event of a violation, the complainants or whoever the signatories are to 10 the agreement are to provide very specific notice 11 12 to the establishment and provide 30 days to cure. And that notice is to be made by certified mail. 13 14 The record is currently devoid of that We don't have any evidence that notice 15 evidence. 16 was provided in the form other an email. As a 17 result, we are not able to move forward, at this 18 time, and we would ask that the case be 19 dismissed. Thank you. 20 CHAIRPERSON ANDERSON: All right. 21 Thank you, Mr. Rivero. I guess I don't need to

ask the applicant, the licensee whether or not

1 they agree with it. 2 So unless you want to say something, Mr. -- unless you want to say something? 3 4 MR. MIRZADEH: No. 5 CHAIRPERSON ANDERSON: Sometimes it's best not to say anything. 6 7 MEMBER SILVERSTEIN: Sometimes it's 8 best to take yes for an answer. 9 CHAIRPERSON ANDERSON: Well, with that 10 said, I make a motion that we accept the Government's Motion to Dismiss. Is there a 11 12 second? 13 MEMBER SILVERSTEIN: I second, Mr. 14 Chairman. 15 CHAIRPERSON ANDERSON: Mr. Silverstein 16 has seconded the motion. 17 All those in favor say aye. 18 ALL: Aye. 19 CHAIRPERSON ANDERSON: Those opposed? 20 All right. So the matter passes 7-0-0. Yeah, the matter passes 7-0-0. 21 We will issue a Board order on this 22
