4	in our calendar is Case No. 19-AUD-00040, MXDC,				
5	License No. 90420. Will the parties please				
6	approach and identify themselves for the record,

8	MR. LUI: Good morning, Board members.				
9	John Lui on behalf of the District of Columbia.				
10	CHAIRPERSON ANDERSON: Mr. Lui.				
11	MR. TAVERA: Good morning. My name is				
12	Anthony Tavera. I'm representing MXDC				
13	Restaurant.				
14	CHAIRPERSON ANDERSON: Your last name?				
15	MR. TAVERA: Tavera, T-A-V-E-R-A.				
16	CHAIRPERSON ANDERSON: Oh, I'm sorry.				
17	Okay. There's a sign-in sheet. Please sign in,				
18	sir. All right. Are there any preliminary				
19	matters in this case?				
20	MR. LUI: Yes, Mr. Chairperson.				
21	CHAIRPERSON ANDERSON: And what is				
22	that, please?				
23	MR. LUI: We have an offer in				
24	compromise to present to the Board.				
25	CHAIRPERSON ANDERSON: And what is				

that offer in compromise, please? 1 2 MR. LUI: For Charge 1, we have a 3 2,000-dollar fine payable within 30 days or its 4 license shall be suspended indefinitely until 5 this fine is paid. And submit pending quarterly statements if they have not been submitted yet. 6 7 CHAIRPERSON ANDERSON: Is there a timeline? 8 9 MR. LUI: Within 30 days. 10 CHAIRPERSON ANDERSON: Mr. Tavera, 11 it's my understanding that there is an offer in 12 compromise. And the offer in compromise is that 13 for Charge 1, there is a fine of 2,000 dollars 14 payable within 30 days of the fine. 15 If it's not payable within 30 days, your license will be suspended until the fine has 16 17 been paid. And secondly, that all outstanding reports will be filed within 30 days. Is this 18 19 your understanding, sir, of the offer in 20 compromise? 21 Yes, we accept the offer. MR. TAVERA: 22 CHAIRPERSON ANDERSON: Are you aware 23 that by accepting an offer in compromise that 24 you're giving up your right to a hearing?
