3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 18-CMP-00167,
5 Maketto, License No. 90445.

6 Would the parties, please, approach
7 and identify themselves for the record, please?

8 MR. RIVERO: Indulgence. Fernando
9 Rivero for the District of Columbia.

10 CHAIRPERSON ANDERSON: Mr. Rivero.

11 MS. YOHANNES: Okay. Sidon Yohannes
12 on behalf of the licensee.

13 CHAIRPERSON ANDERSON: Good morning,
14 Ms. Yohannes. I think you forgot how to bring
15 your name out this morning, it's okay. All right.

16 Are there any preliminary matters in
17 this case?

18 MR. RIVERO: The parties do not have
19 an Offer in Compromise to present to the Board,
20 at this time, and the Government is ready to move
21 to the next scheduled date.

22 CHAIRPERSON ANDERSON: All right.

1 Then this matter then is scheduled for a Show
2 Cause Hearing on January 30th at 3:30 p.m.

3 And as I have stated, moving forward,
4 it's the expectation of the Board that for Show
5 Cause Hearings, seven days prior to the hearing
6 that each side should disclose documents and
7 witnesses to the opposing party and to the Board
8 prior to the hearing.

9 That is my expectation and if this is
10 not done, then the Board will see what type of
11 remedy it will do if that has not been done.

12 As I have made it known, it is
13 difficult to do a Show Cause Hearing when folks
14 are -- I don't know what the documents are. I
15 don't know who the witnesses are. Folks are
16 coming with flashdrives that either side has not
17 seen.

18 And so we need to put some formality
19 to this process, so just it's going to be -- we
20 will announce at all Show Cause (Status) Hearings
21 that turns into full-blown hearings.

22 So anyway, January 30, 2019 at 3:30.

1 Yes, Mr. Rivero?

2 MR. RIVERO: For the record, to whom
3 are the witness list and documents provided?

4 CHAIRPERSON ANDERSON: I would like
5 them --

6 MR. RIVERO: To the Board seven days
7 prior.

8 CHAIRPERSON ANDERSON: I would ask that
9 they be sent to the attention of the General
10 Counsel.

11 MR. RIVERO: All right.

12 CHAIRPERSON ANDERSON: Thank you. Then
13 it will make itself to us, but as -- and I will -
14 - the General Counsel is on board and so the
15 General Counsel will make sure that this
16 information is shared with the Board Members.
17 All right.

18 MR. RIVERO: Thank you.

19 CHAIRPERSON ANDERSON: Thank you very
20 much.
