**ORDER GRANTING PETITIONER'S MOTION FOR RECONSIDERATION  
AND REINSTATEMENT OF LICENSE**

---

On September 12, 2018, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CT License No. ABRA-090204 held by La Kazbah, LLC, t/a Marrakech/Aura Lounge, because Marrakech/Aura Lounge failed to surrender its license to the Board for safekeeping after it ceased operations. *See* Board Order No. 2018-519.

On October 16, 2018, Andrew Kline, Esq., on behalf of La Kazbah, LLC (Petitioner), sought reinstatement of the Retailer's Class CT License No. ABRA-090204. In support of his Motion for Reconsideration, Mr. Kline stated that the Petitioner did not receive proper notice from the Board requesting that it surrender its ABC license for safekeeping or the Board would cancel its ABC license.

The Board finds good cause to grant the Motion to reinstate with the condition that the Petitioner surrenders its ABC License for safekeeping and pays the required fees.

Accordingly, it is this 24th day of October, 2018, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against La Kazbah, LLC, t/a Marrakech/Aura Lounge, by the Board on September 12, 2018, be and hereby is **VACATED**.

**IT IS FURTHER ORDERED** that the Retailer Class CT License ABRA-090204 be **REINSTATED**.

**IT IS FURTHER ORDERED** that the Petitioner surrenders its ABC License No. ABRA-090204 for safekeeping and pays the required fees within two (2) weeks from the date of this Order.







Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
