3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 17-CC-00117, Mason
5 Inn, License No. 104588.

6 Will the parties, please, approach and
7 identify themselves for the record, please?

8 MR. SOUSA: Christopher Sousa for the
9 District of Columbia.

10 CHAIRPERSON ANDERSON: Mr. Sousa, I
11 see that the licensee is not here.

12 MR. SOUSA: Yes.

13 CHAIRPERSON ANDERSON: Are you
14 expecting them to be here today?

15 MR. SOUSA: We were expecting them to
16 be here today.

17 CHAIRPERSON ANDERSON: Do you want me
18 to wait or what do you want? What do you
19 recommend?
