There are 15 four individuals from your group present today. 16 That means that your group is, excuse me, granted 17 conditional standing. Is the Applicant present? The time is 1 2 approximately 10:10. The Applicant is not 3 present. The application for license renewal is 4 dismissed. 5 What that means, Mr. Nehmetallah, is that the application is dismissed. The Applicant 6 7 is not present. The Board will issue an order 8 dismissing the application. 9 You will receive a copy of that order. 10 If the Applicant seeks reinstatement, you'll be 11 informed and have an opportunity to respond to 12 that as well. 13 Is your contact information on that 14 sheet? There was a sheet of paper on the table. 15 Only the designated representative needs to fill 16 out that sheet. You could give that to Mr. 17 Nehmetallah. MR. NEHMETALLAH: And I will fill the 18 19 form? 20 MS. FLETCHER: Yes. That's how we'll 21 communicate with you beyond today. 22 MR. NEHMETALLAH: Okay. So, may I ask 23 a question? 24 MS. FLETCHER: Yes. 25 MR. NEHMETALLAH: That means we have

to redo everything or this is your decision is final?

MS. FLETCHER: Yes. The decision in terms of whether or not the application is dismissed, that rests with the Board. The application is dismissed as of this moment because the Applicant is not here.

But the Applicant will have an opportunity to ask the Board to reconsider what I've said today. And if the Applicant provides the Board with good cause or good reason the Board can reinstate the application.

If that happens, I will be informed of that and then I'll contact you and we'll need to set up some dates for some upcoming proceedings, including a mediation. But you'll be kept informed.

And you've got my card. If you have any other questions just give me a call. But is there any other question today though, from anybody? Okay, well thank you. The roll call hearing is concluded. Thank you very much.
