4 next case on our calendar is Case No. 19-CMP-
5 00058, My Canton Restaurant, License No. 75479.

6 Will the parties, please, approach and
7 identify themselves for the record, please?

8 MS. MARKS: Lindsay Marks for the
9 District of Columbia.

10 CHAIRPERSON ANDERSON: Good morning,
11 Ms. Marks.

12 Could you, please, remove your hat,
13 sir? You are, sir?

14 MR. PAPPAS: I represent Mr. Polio.
15 My name is Mike Pappas. He is New Canton
16 Restaurant.

17 CHAIRPERSON ANDERSON: You are -- I'm
18 sorry, so you are Mr. Pappas. You are the
19 representative. And I'm sorry, what's the
20 person's name next to you?

21 MR. POLIO: My name is Jose Polio. I
22 am the owner of My Canton.

1 CHAIRPERSON ANDERSON: Okay. All
2 right. Are there any preliminary matters in this
3 case?

4 MS. MARKS: No, Mr. Chair.

5 CHAIRPERSON ANDERSON: All right.
6 Then this matter then is scheduled for a Show
7 Cause Hearing on October 23rd at 10:00 a.m.

8 Are you an attorney, sir?

9 MR. PAPPAS: Me?

10 CHAIRPERSON ANDERSON: Yes.

11 MR. PAPPAS: No, sir. I'm a permit
12 processor.

13 CHAIRPERSON ANDERSON: I'm sorry. I'm
14 asking a different question. I'm fine. I was
15 just asking. You said you are the -- so will you
16 be at the hearing representing him?

17 MR. PAPPAS: Yes, sir.

18 CHAIRPERSON ANDERSON: You are -- make
19 sure that you file some paperwork to say that you
20 are the designated representative for him at the
21 hearing.

22 MR. PAPPAS: Okay.

1 CHAIRPERSON ANDERSON: All right.
2 This matter is scheduled for a Show Cause Hearing
3 on October 23rd at 10:00.

4 MR. PAPPAS: Okay. Thank you.

5 CHAIRPERSON ANDERSON: What I require
6 from both parties seven days prior to the hearing
7 you are supposed to exchange documents and
8 witnesses with each side and with the ABC Board.

9 Meaning that whatever witnesses you
10 are going to call, whatever documents you are
11 going to rely on, I expect that you exchange
12 these documents with both parties.

13 If these documents are not exchanged
14 seven days before the hearing, unless good cause
15 is shown, the Board might not allow documents and
16 witnesses to be relied upon at the hearing that
17 were not disclosed seven days prior.

18 Are both parties fully understanding
19 of the process?

20 MS. MARKS: Yes, Mr. Chairman.

21 CHAIRPERSON ANDERSON: All right.

22 Thank you very much. All right. So October 23rd

1 at 10:00 a.m. is when we will have our hearing.

2 Thank you.

3 MEMBER SHORT: Mr. Pappas?

4 MR. PAPPAS: Yes, sir?

5 MEMBER SHORT: Are you the Mr. Pappas

6 who lives in Hillcrest, SE?

7 MR. PAPPAS: Yes, sir.

8 MEMBER SHORT: I remember you, sir,

9 and I remember your sister. Thank you for your
10 service over the years.

11 MR. PAPPAS: Oh, okay. You're
12 welcome.

13 CHAIRPERSON ANDERSON: Why don't --
14 you can step back, sir, and fill the form and
15 provide that to our representative.

16 MR. PAPPAS: Okay.

17 CHAIRPERSON ANDERSON: Okay. Thank
18 you.
